WIRELESS TELEGRAPHY ORDINANCE (CAP.78)

Wireless Telegraphy (Broadcast Licence Charges)  
(Amendment) Regulations, 1965

Date of commencement:

IN exercise of the powers conferred by section 5 of the Wireless Telegraphy Ordinance, the Honourable the Prime Minister has made the following regulations:-

Citation and commencement.

1. (1) These regulations may be cited as the Wireless Telegraphy (Broadcast Licence Charges) (Amendment) Regulations, 1965, and shall be read and construed as one with the Wireless Telegraphy (Broadcast Licence Charges) Regulations, 1962, hereinafter referred to as "the principal regulations".

(2) These regulations shall come into force on the

Amendment of Regulation 7 of the principal regulations.

2. For regulation 7 of the principal regulations there shall be substituted the following:-

"Place of payment of fees 7. The fees prescribed by the regulations in respect of broadcast receiving licences for apparatus -

(a) in any area specified in the first column of the Third Schedule hereto shall be payable in the Police Station specified for such area in the second column of the said Schedule, and

(b) in non-foreign going water craft shall be payable in the Newport Police Station, Marsa."

Insertion of new Schedule in the principal regulations.

3. Immediately after the Second Schedule to the principal regulations there shall be inserted the Schedule contained in the Schedule to these regulations.

FEES ORDINANCE (C.F. 58)

Fees (Wireless Telegraphy) (Amendment)  
Regulations, 1965

Date of commencement:

IN exercise of the powers conferred by section 2 of the Fees Ordinance, the Honourable the Prime Minister has made the following regulations:-

1. (1) These regulations may be cited as the Fees (Wireless Telegraphy) (Amendment) Regulations, 1965, and shall be read and construed as one with the Fees (Wireless Telegraphy) Regulations, 1959, hereinafter referred to as "the principal regulations".

(2) These regulations shall come into force on the
