MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap 136)

The attached draft Declaration by His Excellency the Acting Governor-General refers to the acquisition of several premises and part of a garden at Villambrosa Street and at Victoria Avenue, Hamrun.

Since these premises and part of a garden are permanently required by the Government, it is proposed to acquire them by absolute purchase.

The said land is required in connection with the extension of Villambrosa Street and of Victoria Avenue, at Hamrun; it is therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance, Chapter 136.

From the report by the Land Engineer it transpires that the total freehold value of the above land amounts to £5,401. 1. 0.

Honourable Ministers are invited to recommend.

DECLARATION BY THE A/GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

Part of the garden of premises No. 102, Villambrosa Street, measuring 7.40 square canes, including a room measuring 80 c are feet, bounded on the South and on the East by property of Mr. Victor Quintano, on the North by property of the Very Reverend Canon Archpriest J.C. Burlo D.D. and others and on the West-South-West by the remaining portion of the garden of which it forms part; it is the property of the Society of Christian Doctrine.
