

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of six plots of land at Hondoq ir-Rummien, Qals, Gozo.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with a desalination plant; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £1334. 0. 0d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Hondoq ir-Rummien, Qala, Gozo:

1. A plot of land of the area of 5 Tumoli, 1 Siegh and 1 Kejla, bounded on the South by property of the Society of Jesus, on the South-East by property of Mr. Paul Camilleri, and on the West, North and East by the remaining portion of the land of which such plot forms part; it is the property of Saint Augustine's Convent of Valletta.
2. A plot of land of the area of 3 Sieghan, bounded on the North-West and North-East by property of Saint Augustine's Convent of Valletta, and on the South-West and South-East by property of Reverend Angelo Camilleri; it is the property of Mr. Paul Camilleri.
3. A plot of land of the area of 3 Sieghan, bounded on the North-West and North-East by property of Mr. Paul Camilleri, and on the South-West and South by property of Mr. Angelo Mizzi; it is the property of Reverend Angelo Camilleri.
4. A plot of land of the area of 3 Sieghan, bounded on the North and North-East by property of Reverend Angelo Camilleri, and on the South-West by property of the Society of Jesus; it is the property of Mr. Angelo Mizzi.
5. A plot of land of the area of 8 Tumoli, 2 Sieghan, and 5 Kejllet, bounded on the North by property of Saint Augustine's Convent of Valletta, on the North-East partly by property of Mr. Angelo Mizzi, partly by property of Saint Augustine's Convent of Valletta, and partly by the sea, and on the West and South by the remaining portion of the land of which such plot forms part; it is the property of the Society of Jesus.

6. A plot of land of the area of 3 Sighan, bounded on the South-West by property of the Society of Jesus, on the South-East by Hondoq ir-Rumman Bay, and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Saint Augustine's Convent of Valletta.

The abovementioned land is shown on a plan marked L.D. 127/69, which may be seen on demand at the Land Office, 29, South Street, Valletta.
