MEMORANDUM FOR THE CABINET BY THE HON. MINISTER OF AGRICULTURE, POWER & COMMUNICATIONS

Amendment of the Fishing Regulations in connexion with the extension of the "Lampuki" season

Section 300 of the Code of Police Laws (Cap. 13) empowers the Governor to make regulations respecting fishing and fishing boats, the sale of fish, by auction or otherwise, as well as the grant of licences in connection therewith.

- 2. The Fisheries Board decided at its last meeting that the "Lampuki" season should be extended up to the end of November. To implement this decision would require the amendment of regulation 25 of the Fishing Regulations published by Government Notice No. 206 of the 25th May, 1934 (copy at Appendix "A") which lays down that the season should end on 31st October of each year.
- 3. A Legal Notice to amend the regulations accordingly has been prepared by the Attorney General's Office and a copy is enclosed at Appendix "B".
- 4. Hon. Ministers are asked to say whether they agree that the Governor be advised to make the proposed regulation extending the Lampuki season up to the 30th November.

Extract from Government Notice No. 206 of 25. 5. 34

IN exercise of the powers conferred on the Governor by Article 286 of the Police Laws, His Excellency has been pleased to make the following Fishery Regulations.

Government Notice No. 174 of the 30th May, 1932, is hereby repealed.

The Kannizzati Fishery

- 24. The fishing positions used in the "Kannizzati" fishery shall be allocated each year by lot under such conditions as the Controller may deem fit to impose and it shall not be lawful to lay any floats for this method of fishing without a licence.
- 25. Such licence shall be effective for the period beginning on the 15th August and ending on the 31st October during which period no person other than the licensee shall be allowed to fish within a radius of six hundred feet from the floats of his own "Kannizzati".
- 26. It shall be lawful for the Controller to limit the issue of these licences to bona fide fishermen only.

CODE OF POLICE LAWS (CAP. 13)

Fishery (Amendment) Regulations, 1962

Date of commencement:

In exercise of the powers conferred by section 300 of the Code of Police Laws the Governor has made the following regulations:-

Citation.

1. These regulations may be cited as the Fishery (Amendment) Regulations, 1962, and shall be read and construed as one with the Fishery Regulations published by Government Notice No. 206 of the 25th May, 1934, hereinafter referred to as "the principal regulations".

Amends regulation 25 of the principal regulations. 2. In regulation 25 of the principal regulations for the figures and words "31st October" there shall be substituted the figures and words "30th November".
