## MEMORANDUM FOR CABINET BY THE HON MINISTER OF JUSTICE

## LAND ACQUISITION (FUBLIC FURPOSES) CRDINANCE, CAP. 136

It is proposed to acquire 16 plots of land at Mosta described in the attached Declaration. The land is required for the erection of a school.

As the acquisition is being made for a public purpose, Hon. Members are invited to recommend.

## DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

## Description of the Land

The following sixteen plots of land at Mosta:

- 1. A plot of land of the area l Tomna, 4 sieghan and 0.13 kejliet, bounded on the North-East partly by property of Mr Angelo Galea and partly by property of Mr Nicholas Trapani Galea, on the North-West by property of Mr Nicholas Mallia Tabone and on the South-West by property of Mr Andrew Galea and others; it is the property of the Mosta Parish Church.
- 2. A plot of land of the area of 2.18 kejliet, bounded on the North-East by property of the Mosta Parish Church, on the North-West by property of Miss Grace Debono and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Andrew Galea.
- 3. A plot of land of the area of 3.95 kejliet, bounded on the South-East by property of Mr Andrew Galea, on the North-East by property of the Mosta Parish Church and on the North-West by property of Mrs Thereas Galea; it is the property of Miss Grace Debono.
- 4. A plot of land of the area of 1 siegh and 0.76 kejliet, bounded on the North-North-West by property of Mr Nicholas Mallia Tabone; on the North-West by property of Miss Marianna Grech and others and on the South-West by property of Mr Francis Sammut; it is the property of Mrs Theress Galea.
- 5. A plot of land of the area of 5 sieghan and 5.23 kejliet, including a rural room and a well, bounded on the North-North-West and on the North-East by property of Mr Nicholas Mallia Tabone and on the South-South-East partly by property of Mr Francis Sammut and partly by property of Mrs Theresa Galea; it is the property of Michael Marianna Grech and others.
- 6. A plot of land of the area of 1 siegh and 4.31 kejliet, bounded on the North-West by property of Mr Nicholas Trapani Galea, on the South-West by property of the Mosta Parish Church and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Mr Angelo Galea.
- 7. A plot of land of the area of 1 siegh and 8.82 kejliet, bounded on the South-East by property of Mr Angelo Galea, on the North-West by property of Mr D. Pellegrini Chetcuti and on the South-West by property of the Mosta Parish Church; it is the property of Mr Nicholas Trapani Galea.

- 8. A plot of land of the area of 5 sieghan and 9.45 kejliet, bounded on the South-West by property of Mr Nicholas Mallia Tabone, on the South-East by property of Mr Nicholas Trapani Galea and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Mr D. Pellegrini Chetcuti.
- 9. A plot of land of the area of 7 tmien, 4 sieghan and 7.43 kejliet, including a farmhouse and a well, bounded on the North-East by property of Mr D. Pellegrini Chetcuti, on the North, on the North-North-West and on the West-North-West by property of the Government of Malta, on the West-South-West and on the South-South-East partly by property of Miss Marianna Grech and others and partly by property of the Mosta Parish Church; it is the property of Mr Nicholas Mallia Tabone.
- 10. A plot of land of the area of 5.4 kejliet, bounded on the North-North-West by property of Miss Marianna Grech and others, on the North-East by property of Mrs Theresa Galea and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of Mr Francis Sammut.
- 11. A plot of land of the area of 0.55 kejliet, bounded on the East-North-East by property of Miss Marianna Grech and others, on the North-North-West by property of Mr Nicholas Mallia Tabone and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of Miss Victoria Buhagiar.
- 12. A plot of land of the area of 0.3 kejliet, bounded on the East-South-East by property of Mr Nicholas Mallia Tabone, on the North-North-East partly by property of the Government of Malta and partly by property of the "Societa' Anime Purganti" attached to the Church of St Nicholas of Bari of Valletta and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of Miss Rosa Salomone.
- 13. A plot of land of the area of 4 tmien, 4 sieghan and 3.7 kejliet including a rural room and a "Girna", bounded on the East-South-East, on the South-East and on the North-East by property of the Government of Malta and on the South-South-West by property of Miss Rosa Salomon it is the property of the "Societa' Anime Purganti" attached to the Church of St Nicholas of Bari of Valletta.
- 14. A plot of land of the area of 8.81 kejliet, bounded on the East-South-East by property of the "Societa" Anime Purganti" attached to the Church of St Nicholas of Bari of Valletta, on the North-North-East by property of Mr Saviour Chetcuti and on the West-North-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Saviour Pisani.
- 15. A plot of land of the area of 2 sieghan and 9.9 kejliet, bounded on the East-South-East and on the South-East partly by property of the Government of Malta and partly by property of the "Societa' Anime Purganti" attached to the Church of St Micholas of Beri of Valletta,

on the South-South-West by property of Mr Saviour Pisani and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Saviour Chetcuti.

16. A plot of land of the area of 2 sieghan and 6.84 kejliet, bounded on the South-West and on the North-West by property of the Government of Malta and on the South-East by property of Mr D. Pellegrini Chetcuti; it is the property of Mr Anthony Bezzina.
