

Memorandum by the Hon. Minister of Justice

Land Acquisition (Public Purposes) Ordinance, (Cap.136)

The land to be acquired is situate at Mgarr and the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) are being made use of in view of the public purpose involved. The site is being acquired by way of absolute purchase for the setting up of a children's playground.

The attached Declaration gives a description of the land to be acquired.

DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Mgarr, Malta:-

1. A plot of land of the area of $40\frac{5}{8}$ square canes, bounded on the North by Jubilee Esplanade, on the East by Sir Harry Luke Street, and on the West by property of Mr. John Muscat; it is the property of the heirs of Salvatore Muscat.
2. A plot of land of the area of $40\frac{5}{8}$ square canes, bounded on the North by Jubilee Esplanade, on the East by property of Salvatore Muscat and on the West by property of Mr. Salvatore Galea; it is the property of Mr. John Muscat.
3. A plot of land of the area of $40\frac{5}{8}$ square canes, bounded on the North by Jubilee Esplanade, on the East by property of Mr. John Muscat and on the West by property of Mr. Lorenzo Galea; it is the property of Mr. Salvatore Galea.
4. A plot of land of the area of $40\frac{5}{8}$ square canes, bounded on the North by Jubilee Esplanade, on the East by property of Mr. Salvatore Galea and on the West by property of Mr. Michael Gauci; it is the property of Mr. Lorenzo Galea.
5. A plot of land of the area of $40\frac{5}{8}$ square canes, bounded on the North by Jubilee Esplanade, on the East by property of Mr. Lorenzo Galea, and on the West by property of Mr. John Muscat; it is the property of Mr. Michael Gauci.
6. A plot of land of the area of $48\frac{1}{2}$ square canes, bounded on the North by the above mentioned five plots, on the East by Sir Harry Luke Street and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. John Muscat.

The above mentioned land is shown on plan marked L.D. 115/63 which may be seen on demand at the Land Office, 29, South Street, Valletta.
