Memorandum by the Minister of Justice

Lend Acquisition (Public Purposes) Ordinance (Chapter 136)

The attached declaration proposes to acquire by absolute purchase a plot of land in the limits of Zejtun and Ghaxaq called "Tal-Barrani" for the widening of Tarxien - Bir id-Deheb road.

The land in question is required for a public purpose and In accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance, Chapter 136.

The expropriation of the 26 plots involved is valued £2,494.9s.8d.

DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land
