Memorandum by the Minister of Justice

Land Acquisition (Public Purposes) Ordinance Chapter 136

The attached Declaration coveres 19 plots of land connected with the Second Phase of the Sliema Regional Read.

The acquisition is to be made by absolute purchase. The property is situated at St. Julian's stretching from the neighbourhood of the Sacred Heart Convent to the St. Julian's - St. Andrews Road.

The land is to be acquired for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance Chapter 136.

It emerges from the valuation report of the Land Engineer that the value of the 19 plots in question amounts to £15,936. 14s. 11d.

Hon. Members are invited to recommend.

DECLARATION BY THE GOT LINGS

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Saint Julians:-

- l. by property of Mr. Roger Degiorgio A.& C.S. and partly by property of Mr. Carmelo Falzon A. & C.E. and on the West by the remaining portion of the land of which such plot forms part; it is the property of the House Building Group Limited as regards the perpetual utile dominium and of Captain John Bonavita as regards the directum dominium.

- Street, The Gardens, of the area of 2 square cases, bounded on the North-West by property of Mrs. Paulina Zammit, on the South-West by property of the House Building Group Limited and on the East by the remaining portion of the land of which such villa forms part; it is the property of Messrs. Edwin and Richard England Sant Fournier as regards the perpetual sub-utile dominium of the House Building Group Limited as regards the perpetual sub-directum dominium and of Mr. Giuliano Grech as regards the directum dominium.
- 11. A plot of land of the area of 521 square cames, bounded on the North-Jest by property of Mr. Joseph Scicluma on the South-East partly by property of Messrs. Edwin and Richard England Sant Fournier and partly by property of the House Building Group Limited, on the East and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mrs. Paulina Zammit.

A plot of land of the area of 90 square cames, bounded on the North-East by property of Mrs. Mary Cassar and others, on the South-East by property of Mrs. Paulina Zammit and on the Jest by the remaining portion of the land of which such plot forms part; it is the property of Mr. Joseph Scicluma.
- 13 A plot of land of the area of 2.6 square cames, bounded on the North-East and on the South-East by property of Mr. Joseph Scicluna and on the Jest by the remaining portion of the land of which such plot forms part; it is the property of Mr. Jichael Cini and others.

- 14. A plot of land of the area of 81 square cames, bounded on the North-West and on the South-West by property of Mr. Joseph Scicluma and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mrs. Mary Cassar and others.
- 15. A plot of land of the area of 130 square canes, bounded on the North-East partly by property of the House Building Group Limited and partly by property of Mr. Michael Cini and others, on the South-East by property of Mrs. Mary Cassar and others, on the East and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Joseph Scicluna.
- bounded on the South-Last by property of Mr. Joseph Scicluma, on the North-Last by property of Mr. Michael Cini and others and on the East by the remaining portion of the land of which such plot forms part; it is the property of the House Building Group Limited as regards the perpetual sub-utile dominium of Mr. Michael Cini and Mr. Francis Sciberras as regards the perpetual sub-directum dominium and of unknown owner or owners as regards the directum dominium.
- 17. A plot of land of the area of 243.6 square canes, bounded on the North-West by property of Mr. John Francia on the South partly by property of Mr. Joseph Scicluma and partly by property of the House Building Group Limited on the Sast and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Michael Cini and others;
- 18. A plot of land of the area of 748 square canes, bounded on the North-Nest partly by property of Dr. Toseph Attard Montalto and others and partly by St. Andrews Road, on the South-Sast by property of Mr. Michael Cini and others, on the South-East and on the West by the remaining portion of the land of which such plot forms part; at is the property of Mr. John Francia.

A plot of land including part of an alley of the area of 31.3 square canes, bounded on the North by St. Andrews Road, on the South-Jest by property of Mr. John Francia and on the South-East by the remaining portion of the of hich such plot forms part; it is the property of Dr. Joseph Attard Hontalto and others.
