Memorandum by the Minister of Justice Land Acquisition (Public Purposes) Ordinance (Chapter 136)

The attached Declaration by His Excellency the Governor-General covers five plots of land including some immovable structures or parts thereof situated in Zabbar. It is proposed to acquire by absolute purchase.

The acquisition of the five plots in question are required for the construction of a Civic Centre at Zabbar and therefore in connection with a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).
