MEMORANDUM BY THE MINISTER OF JUSTICE LAND ACQUISITION (FUBLIC PURPOSES) ORDINANCE CAP. 136

The attached Declaration by His Excellency the Acting Governor-General covers eleven plots of land within the limits of grendi.

The land under review is required by Government in connection with improvements to be carried out in the road leading to the Magar Qim Temples. It is therefore, required for a public purpose in accorandce with the provisions contained in the Land Acquistion (Public Purposes) Ordinance Cap. 136.

It is proposed to acquire by title of absolute purchase and it emerges from the report submitted by the Land Engineer that the freehold value of the eleven plots in question having regard to similar land if sold on the open market and all other factors concerned would amount to £847.17s.9d.

 - 10. A plot of land of the area of 98.03 square canes, bounded on the South, on the South-West and on the South-East by Our Lady of Graces Street and on the North by the remaining portion of the land of which such plot forms part, it is the property of Mr Giovanni Falzon.

A plot of land of the area of 53.1 square canes, bounded on the North-North-West and on the North-East by Our Lady of Graces Street and on the South by the remaining portion of the land of which such plot forms part; it is the propert of Mrs Marianna Cassar as regards the temporary Utile Dominium.
