

Memorandum by the Minister of Justice  
Land Acquisition (Public Purposes) Ordinance  
(Chapter 136)

The attached Declaration by His Excellency the Acting Governor-General covers nine plots of land within the limits of Msida. It is proposed to acquire by title of absolute purchase.

The land under review is required by Government in connection with the Hamrun By-pass. It is therefore required for a public purpose in accordance with the Land Acquisition (Public Purposes) Ordinance Cap.136.

No immovable structures are involved in the proposed acquisition.

It transpires from the report by the Land Engineer the total valuation in consideration of the freehold value of the property in question would amount to £10 708.6s.4d.

Honourable Ministers are all invited to recommend.

DECLARATION BY THE ACTING GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Msida:-

1. A plot of land of the area of 1 tonna and 6.5 kejllet, bounded on the North-East by the Sliema Regional Road and on the North, on the West and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of the Franciscan Minor Conventuals of Valletta.

2. A plot of land of the area of 5 sieghan and 6.28 kejllet, bounded on the North by property of the Franciscan Minor Conventuals of Valletta, and on the West and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mrs Mary F. Pace and others.

3. A plot of land of the area of 0.86 kejllet, bounded on the North and on the West by property of Messrs C. Borg and Mallia, and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mrs Mary F. Pace and others.

4. A plot of land of the area of 1 tonna 4 sieghan and 5 kejllet, bounded on the North by property of Mrs. Mary F. Pace and others, on the South by Tower Street and on the West by the remaining portion of the land of which such plot forms part; it is the property of Messrs. C. Lorg and Mallia.

5. A plot of land of the area of 1 siegh and 4.1 kejliet including a farmhouse, bounded on the North by Tower Street, on the South by property of Mr. Joseph Darmanin, and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mrs. Giovanna Vella.

6. A plot of land of the area of 3 tmien 4 sieghan and 4.5 kejliet, bounded on the North partly by Tower Street and partly by property of Mrs. Giovanna Vella, on the South and on the East by a lane and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Joseph Darmanin.

7. A plot of land of the area of 3 sieghan and 2.82 kejliet, bounded on the North and on the East by a lane, and on the South by property of Mr. Francis Azzopardi; it is the property of Mrs. Rosina Guaci.

8. A plot of land of the area of 1 tomna 2 sieghan and 8.44 kejliet, including a rural room, bounded on the North by property of Mrs. Rosina Guaci and on the West and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mr. Francis Azzopardi.

9. A plot of land of the area of 0.173 kejliet, forming part of a passageway, bounded on the North by property of Mr. Francis Azzopardi, on the South by a lane and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Joseph Guaci.
