## MEMGRANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY APPLIES

Jand Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the acquisition of 16 plots of land in the limits of Dingli.

An these plots of land are permanently required by the Government, it is proposed to acquire them by absolute purchase.

The said 16 plots of land are required in connection with the construction of the Panoramic Road at Dingli Cliffs; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the said 16 plots of land amounts to £3808. Os.Od.

## DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

## Description of the land

The following land at tal-Pitkal, limits of Dingli:-

A plot of land of the area of 1 siegh and 5 kejliet, bounded on the South-West by property of Mr. Alexander Sant and others, on the North-West by property of Mr. Gio Maria Parrugia and on the North-East by the remaining portion of the land of which it forms part; it is the property of Mr. Carmelo Cachia.
- 7. A plot of land of the area of 4 kejliet, bounded on the South-West by a public road, on the North-West by property of Mrs. Margerita Griscii and on the North-Bast by the remaining portion of the land of which it forms part; it is the property of Mr. Carmelo Cachia.
- 8. A plot of land of the area of 5.35 kejliet, bounded on the South-West by a public road, on the South-East by property of Mr. Carmelo Cachia and on the North-East by the remaining portion of the land of which it forms part; it is the property of Mrs. Margerita Grisci.
- 9. A plot of land of the area of 5.7 kejliet, bounded on the South-West by a public road, on the South-Bast by property of Mrs. Margerita Griscii, on the North-Bast by property of Mr. Carmel Cachia and on the Bouth-West by a public road; it is the property of Mr. Carmel Cachia.
- 10. A plot of land of the area of 1 siegh and 3.13 kejliet, bounded on the Bouth-West by property of Mr. Carmel Cachia, on the Bouth-Bast by property of Mrs. Margerita Griscii and on the North-Bast by the remaining portion of the land of which it forms part: it is the property of Mr. Carmel Cachia.
- ll. a plot of land of the area of 2 sieghan and 4.7 kejlict; bounded on the Vest and on the North-Jest by a public road, on the bouth-Last by property of Mr. Carmel Cachia and on the North-Was: by the remaining portion of the land of which it forms part; it is the property of Mr. Carmel Cachia.
- bounded on the wouth-West by a public road, on the North-West by property of Messrs. Carmelo and Paul Scerri and on the North-East by the remaining portion of the land of which it forms part; it is the property of Mr. Anthony Cassar.

- 13. A plot of land of the area of 3 sieghan and 9.3 kejliet, bounded on the South-West by a public road, on the South-East by property of Mr. Anthony Casser and on the North-East by the remaining portion of the land of which it forms part; it is the property of Messrs. Carmelo and Paul Scerri.
- 14. A plot of land of the area of 1 tomns, 5 sieghan and 2 kejliet, bounded on the Jouth-west and on the North-West by a public road, on the South-Bast by property of Messrs. Carmel and Paul Scerri and on the North-Bast by the remaining portion of the landof which it forms part; it is the property of Mr. Joseph Abela.
- 15. A plot of land of the area of 4 tmien, 5 sieghan and 4.26 kejliet, including part of a garage, part of a room and part of a wine well, of the area of 9 square canes; bounded on the South-East and on the South by a public road, on the North-West by property of the legacy "Teresa Fiell in Allard" and on the North-East by the remaining portion of the land of which it forms part; it is the property of wiss Lily Cassar Torreggiani.
- 16. A plot of land of the area of 5 tmien, 5 sieghan and 7.59 Rejliet, bounded on the wouth-west by a public road, on the South-East by property of Miss Lily Cassar Torreggiani and on the North-East by the remaining portion of the land of which it forms part; it is the property of the legacy "Teress Fiell in Allard" administered by the Reverend Joseph Caruana.
