

MEMORANDUM BY THE MINISTER OF JUSTICE AND
PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of thirty-five plots of land at Gharb, Gozo.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The said plots of land are required by the Government of the purpose of road widening; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above 35 plots of land amounts to £321. 3s.10d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Gharb-Gezo:-

6. A plot of land of the area of 4.1 kejllet, bounded on the South by St Lawrence Street, on the West by property of Mr Carmelo Attard and on the North by the remaining portion of the land of which such plot forms part; it is the property of Mr Paul Axiaq.
7. A plot of land of the area of 1 kejla, bounded on the South by St Lawrence Street, on the East by property of Mr Paul Axiaq and on the North by the remaining part of the land of which such plot forms part; it is the property of Mr Carmelo Attard.
8. A plot of land of the area of 1.5 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Carmelo Attard and on the North by the remaining portion of the land of which such plot forms part; it is the property of Miss Marianna Axiaq.
9. A plot of land, consisting of part of an alley, of the area of 0.5 kejla; bounded on the South by St Lawrence Street, on the East by other property of Miss Marianna Axiaq

and on the North by the remaining portion of the land of which such plot forms part: it is the property of Miss Marianna Axiaq.

10. A plot of land, of the area of 5.3 kejllet, bounded on the South by St Lawrence Street, on the East by property of Miss Marianna Axiaq and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Carmelo Axiaq and Miss Marianna Axiaq.

11. A plot of land, of the area of 2.7 kejllet, bounded on the South by St Lawrence Street, on the East by property of Carmelo Axiaq and Miss Marianna Axiaq and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Paul Axiaq.

12. A plot of land, of the area of 1.6 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Paul Axiaq and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Nazzarano Cauchi.

13. A plot of land of the area of 1.6 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Nazzarano Cauchi, and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Louis Caruana.

14. A plot of land of the area of 2.7 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Louis Caruana and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Gio Maria Micallef.

15. A plot of land of the area of 6.2 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Gio Maria Micallef and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Louis Mizzi.

16. A plot of land of the area of 0.8 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Louis Mizzi and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Joseph Grima.

17. A plot of land of the area of 1.9 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Joseph Grima and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Lawrence Cauchi.

18. A plot of land of the area of 1.7 kejllet, bounded on the South by St Lawrence Street, on the East by property of Mr Lawrence Cauchi and on the North by the remaining portion of the land of which such plot forms part: it is the property of Mr Joseph Casar.

19. A plot of land of the area of 3.1 kejllet, bounded on the North by St Lawrence Street, on the East by Corner Street and on the South by the remaining portion of the land of which such plot forms part: it is the property of Mr Joseph Formosa.

20. A plot of land of the area of 0.9 kejlja, bounded on the North by St Lawrence Street, on the East by property of Mr Joseph Feneosa and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Lawrence Tabone.

21. A plot of land of the area of 1.1 kejllet, bounded on the North by St Lawrence Street, on the East by the property of Mr Lawrence Tabone and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Carmelo Axiaq.

22. A plot of land of the area of 0.8 kejlja, bounded on the North by St Lawrence Street, on the East by property of Mr Carmelo Axiaq and on the South by the remaining portion of the land of which such plot forms part; it is the property of Miss Angiolina Camenzuli.

23. A plot of land of the area of 2.8 kejllet bounded on the North by St Lawrence Street, on the East by property of Miss Angiolina Camenzuli and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Emmanuel Pace.

24. A plot of land of the area of 2.9 kejllet, bounded on the North by St Lawrence Street, on the East by property of Mr Emmanuel Pace, and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Reverend Father Pio Portelli.

25. A plot of land of the area of 3.8 kejllet, bounded on the North by St Lawrence Street, on the East by property of the Reverend Father Pio Portelli and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Lawrence Haber.

26. A plot of land of the area of 4.4 kejllet, bounded on the North by St Lawrence Street, on the East by property of Mr Lawrence Haber and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Reverend Father Pio Portelli.

27. A plot of land of the area of 3.3 kejllet bounded on the North by St Lawrence Street, on the East by property of the Reverend Father Pio Portelli and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Emmanuel Tabone.

28. A plot of land of the area of 7.7 kejllet, bounded on the North by St Lawrence Street, on the East by property of Mr Emmanuel Tabone and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Lawrence Haber.

29. A plot of land of the area of 8.2 kejlja, bounded on the North by St Lawrence Street, on the East by property of Mr Lawrence Haber and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Joseph Cauchi.

30. A plot of land of the area of 0.3 kejlja bounded on the North by St Lawrence Street, on the East by property of Mr Joseph Cauchi and on the South by the remaining portion

of the land of which such plot forms part; it is the property of Mr Carmelo Agius.

31. A plot of land of the area of 0.2 kejlja, bounded on the North by St Lawrence Street, on the East by property of Mr Carmelo Agius and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Paul Axiaq.

32. A plot of land of the area of 0.2 kejlja, bounded on the North by St Lawrence Street, on the East by property of Mr Paul Axiaq and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Michael Angelo Cassar.

33. A plot of land of the area of 3.1 kejlja, bounded on the North by St Lawrence Street, on the East by property of Michael Angelo Cassar and on the South by the remaining portion of the land of which such plot forms part; it is the property of Major Henry Emmanuel Sant Cassia.

34. A plot of land of the area of 4.1 kejlja, bounded on the North by St Lawrence Street, on the East by property of Major Henry Emmanuel Sant Cassia and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Gregory Cassar.

35. A plot of land of the area of 5.3 kejlja, bounded on the North by St Lawrence Street, on the East by property of Mr Gregory Cassar and on the South by the remaining portion of the land of which such plot forms part; it is the property of Miss Georgina Apap and Miss Giuseppina Apap.
