MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY AFFAIRS.

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of seven plots of land at Zebbug, Gozo.

Since the said plots of land are permanently required by the Government, it is proposed to acquire them by absolute purchase.

The above land is required by the Government for the purpose of widening Marsalforn Road in Gozo, it is therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above seven plots of land amounts to £56.0.2.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL.

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land.

The following land at Zebbug, Gozo:-

- 1. A plot of land of the area of 19.46 square canes, bounded on the North by property of Mrs. Rosina Said, on the South by property of Miss Annetta Sultana and on the East by Marsalforn Road; it is the property of the heirs of Mr. Anthony Sultana.
- 2. A plot of land of the area of 19.23 square canes, bounded on the North by property of the heirs of Mr. Joseph Sultana, on the South by property of the heirs of Mr. Anthony Sultana, and on the East by Marsalforn Road; it is the property of Mrs. Rosina Said.
- 3. A plot of land of the area of 21.43 square canes, bounded on the North by property of Mr. Salvatore Sultana, on the South by property of Mrs. Rosina Said and on the East by Marsalforn Road, it is the property of the heirs of Mr. Joseph Sultana.
- 4. A plot of land of the area of 23.32 square canes bounded on the North by property of Mr. Lwigi Sultana, on the South by property of the heirs of Mr. Joseph Sultana and on the East by Marsalforn Road; it is the property of Mr. Salvatore Sultana.
- 5. A plot of land of the area of 25.44 square canes bounded on the North by property of Mrs Mary Borg, on the South by property of Mr. Salvatore Sultana and on the East by Marsalforn Road; it is the property of Mr. Lwigi Sultana.

- 6. A plot of land of the area of 21.35 square canes, bounded on the North by property of Mr. Joseph Sultana, on the South by property of Mr. Lwigi Sultana and on the East by Marsalforn Road; it is the property of Mrs. Mary Borg.
- 7. A plot of land of the area of 19.59 square canes, bounded on the North and on the East by Marsalforn Road, and on the South by property of Mrs. Mary Borg; it is the property of Mr. Joseph Sultana.
