

MEMORANDUM BY THE MINISTER OF JUSTICE  
AND PARLIAMENTARY AFFAIRS.

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached draft Declaration by His Excellency the Governor-General refers to the compulsory acquisition of 20 plots of land at Marsa.

Since the land in question is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The said plots of land are required by the Government in connection with the construction of the Hamrun By-Pass; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above 20 plots of land amounts to £7,730.11.11d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Marsa:

1. A plot of land of the area of 16.6 square canes, bounded on the East by a public road, on the North by property of Messrs. Tyresole Limited, and on the South by the remaining portion of the land of which such plot forms part; it is the property of Messrs. The Modern Matches Manufacturing Company Limited.

2. A plot of land of the area of 5 Sieghan and 6.7 Kejliet, bounded on the East by a public road, on the North West by property of the Noble Mario Galea Testaferrata, and on the South partly by property of Messrs. The Modern Matches Manufacturing Company Limited, and partly by the remaining portion of the land of which such plot forms part; it is the property of Messrs. Tyresole Limited.

3. A plot of land of the area of 4.3 Kejliet, bounded on the South and West by property of Messrs. Tyresole Limited, and on the North by the remaining portion of the Land of which such plot forms part; it is the property of Mr. Joseph Mifsud.

4. A plot of land of the area of 2 Sieghan and 4 Kejliet which includes part of a farmhouse bounded on the South-East by property of Messrs. Tyresole Limited, on the North-West by property of Mr. Louis Camenzuli, and on the North by the remaining portion of the land of which such plot forms part; it is the property of the Noble Mario Galea Testaferrata.

5. A plot of land of the area of 77.4 square canes, bounded on the South-East by property of the Noble Mario Galea Testaferrata, on the North by Racecourse Street and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr. Louis Camenzuli.

6. A plot of land of the area of 21 square canes, bounded on the South by Racecourse Street, on the West by property of Messrs. C.F.N. Abela Brothers and on the North by the remaining portion of the land of which such plot forms part; it is the property of Messrs. Fresh Fruit Company Limited and others.

7. A plot of land of the area of 16.96 square canes, bounded on the South by Racecourse Street, on the West by property of Messrs. Fresh Fruit Company Limited and others, and on the North by the remaining portion of the land of which such plot forms part; it is the property of Messrs. C.F.N. Abela Brothers.

8. A plot of land of the area of 85.5 square canes, bounded on the South by Racecourse Street, on the West by Marsa Road, and on the North by the remaining portion of the land of which such plot forms part; it is the property of Messrs. Fresh Fruit Company Limited and others.

9. A plot of land of the area of 19.9 square canes, bounded on the South by property of Mr. Joseph Camilleri, on the East by Marsa Road, and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Paul Attard.

10. A plot of land of the area of 269.1 square canes, bounded on the South by Racecourse Street, on the East by Marsa Road, and on the West by property of Mr. Paul Attard; it is the property of Mr. Joseph Camilleri.

11. A plot of land of the area of 165.8 square canes, bounded on the East by property of Mr. Joseph Camilleri, on the West by property of Messrs. John Bezzina and Sons, and on the North by the remaining portion of the land of which such plot forms part; it is the property of Mr. Paul Attard.

12. A plot of land of the area of 51.6 square canes, bounded on the North by Racecourse Street, on the West by a land, and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Noble S. Testaferrata Moroni Viani.

13. A plot of land of the area of 9.2 square canes, bounded on the North-East by a lane, on the North by Racecourse Street, and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Noble S. Testaferrata Moroni Viani.

14. A plot of land of the area of 29.49 square canes, bounded on the North-East by property of the Government, on the South by Racecourse Street, and on the North by the remaining portion of the land of which such plot forms part; it is the property of the Noble S. Testaferrata Moroni Viani.

15. A plot of land of the area of 1 Tomna, 2 Sieghan, and 2 Kejllet, bounded on the East by property of Mr. Paul Attard, on the West by property of the Noble Mario Galea Testaferrata, and on the South by the remaining portion of the land of which such plot forms part; it is the property of Messrs. John Bezzina and Sons.

16. A plot of land of the area of 4 Sieghan and 2 Kejllet bounded on the East by property of Messrs. John Bezzina and Sons, on the West by property of Mr. Francis Azzopardi, and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Noble Mario Galea Testaferrata.

17. A plot of land of the area of 1 Siegh and 7 Kejllet, bounded on the East by property of the Noble Mario Galea Testaferrata, on the West by a lane and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr. Francis Azzopardi.

18. A plot of land of the area of 1 Tomna, and 5 Kejllet, bounded on the East by a lane, on the West by property of Mr. Salva Cilia, and on the South by the remaining portion of the land of which such plot forms part; it is the property of Dr. Alexander De Firo Gourgion LL.D.

19. A plot of land of the area of 2 Sieghan and 6 Kejliet, bounded on the East by property of Dr. Alexander De Firo Gourgion LL.B., on the West by property of Dr. Albert Hyzler M.D., M.P., and on the North by the remaining portion of the land of which such plot forms part; it is the property of Mr. Salvu Cilia.

20. A plot of land of the area of 2 Tmien, bounded on the East by property of Mr. Salvu Cila, on the South and North by the remaining portion of the land of which such plot forms part; it is the property of Dr. Albert Hyzler M.D., M.P.

The abovementioned land is shown on a plan marked L.D. 157/67, which may be seen on demand at the Land Office, 29, South Street, Valletta.
