

MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY

AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of 6 plots of land in the limits of Marsa and Qormi.

Since the said land is permanently required by the Government it is proposed to acquire it by absolute purchase.

The plots of land in question are required by the Government in connection with the Hamrun-by-Pass; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above 6 plots of land amounts to £14,536. 16s. 8d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at "Tal-Bajjad and Tal-Bajjada" in the limits of Marsa and Qormi.

1. A plot of land of the area of 179.3 square canes, bounded on the South-East by Qormi Road, on the South-West by property of Mr. John Mary Attard, and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of Colonel Roger T.D. Strickland.
2. A plot of land of the area of 3 tmien, 1 siegh and 1.1 kejllet, bounded on the South-East by Qormi Road, on the North-East by property of Colonel Roger T.D. Strickland, and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of Mr. John Mary Attard.
3. A plot of land of the area of 36.1 square canes, bounded on the South-East by Qormi Road, on the South-West by property of the National Macaroni Factory Limited, and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of Mrs. Giuseppa Cassar.
4. A plot of land of the area of 41.5 square canes, bounded on the South-East by Qormi Road, on the North-East by property of Mrs. Giuseppa Cassar, and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of the National Macaroni Factory Limited.
5. A plot of land of the area of 2 sieghan and 2.4 kejllet, bounded on the North-East by property of Colonel Roger T.D. Strickland, on the North-West by Qormi Road, and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of the Malta Bottling Company Limited.
6. A plot of land of the area of 2 tmien, 5 sieghan and 0.5 kejllet, bounded on the North-West by Qormi Road, on the South-West partly by the remaining portion of the land of which such plot forms part and partly by property of the Malta Bottling Company Limited and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Colonel Roger T.D. Strickland.

The abovementioned land is shown on a plan L.D. 14/68, which may be seen on demand at the Land Office, 29, South Street, Valletta.
