

MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY
AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of 11 plots of land at "Ta' l-Ibragg", in Victoria, Gozo.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with the erection of a hospital; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the 11 plots of land in question amounts to £9,123.10s. 0d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at "Ta' l-Ibragg", Victoria, Gozo:-

1. A plot of land of the area of 1 siegh and 4 kejllet, bounded on the North by Archbishop Pietru Pace Street, on the West by a lane and on the East by property of Mr Lwigi Aquilina; it is the property of the Cathedral Chapter of Victoria, Gozo.
2. A plot of land of the area of 3 sieghan and 0.4 kejllet, including a farmhouse, bounded on the North by Archbishop Pietru Pace Street, on the East by property of Mr Giuseppe Mizzi and on the South by property of Mr Felic Micallef; it is the property of Mr Lwigi Aquilina.
3. A plot of land of the area of 2 tmien, 2 sieghan and 7.0 kejllet, bounded on the North by Archbishop Pietru Pace Street, on the West partly by property of Mr Lwigi Aquilina, partly by property of Mr Felic Micallef and partly by a lane, and on the South by property of Mr Emanuel Tabone; it is the property of Mr Giuseppe Mizzi.
4. A plot of land of the area of 3 sieghan and 1 kejla, including a farmhouse, bounded on the North partly by property of the Cathedral Chapter of Victoria, Gozo, and partly by property of Mr Lwigi Aquilina, on the West by a lane and on the East and South by property of Mr Giuseppe Mizzi; it is the property of Mr Felic Micallef.
5. A plot of land of the area of 4 sieghan and 4.3 kejllet bounded on the North by property of Mr Giuseppe Mizzi, on the West by a lane and on the South by property of Mr Salva Refalo; it is the property of Mr Emanuel Tabone.
6. A plot of land of the area of 1 tumolo, 3 sieghan and 1.8 kejllet, bounded on the North by property of Mr Emanuel Tabone and on the West and South by a lane; it is the property of Mr Salva Refalo.
7. A plot of land of the area of 1 tumolo, and 1.5 kejllet, bounded on the North-East by a lane, on the South-East by property of the heirs of the late Carolina Spiteri and on the South-West by property of Mrs Paola Aquilina; it is the property of Mrs Maria Grech.
8. A plot of land of the area of 2 sieghan and 3.6 kejllet, bounded on the North by property of Mrs Maria Grech, and on the West, South and East by property of Mrs Paola Aquilina; it is the property of the heirs of the late Carolina Spiteri.
9. A plot of land of the area of 2 tmien, 3 sieghan and 5 kejllet, bounded on the North partly by property of Mrs Maria Grech, partly by property of the heirs of the late Carolina Spiteri and partly by a lane, on the South partly by property of Felic Micallef and the heirs of the late Anthony Micallef, and partly by property of Mr Michael Angelo Spiteri, and on the East partly by property of the heirs

of the late Carolina Spiteri, and partly by property of Mr Felice Micallef and the heirs of the late Anthony Micallef; it is the property of Mrs Paola Aquilina.

10. A plot of land of the area of 6.6 kejllet, bounded on the North by property of Mrs Paola Aquilina, and on the South-East and South-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Michael Angelo Spiteri.

11. A plot of land of the area of 8.75 kejllet, bounded on the North-East, South-East and South-West by property of Mr Michael Angelo Spiteri, and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Angelo Spiteri.

The abovementioned land is shown on a plan marked L.D.16/68, which may be seen on demand at the Land Office, 29, South Street, Valletta.
