

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS.

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of 15 plots of land at Zebbug, Gozo.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government for road widening purposes; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the plots of land in question amounts to £344.0.7d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Zebbug, Gozo:

1. A plot of land of the area of 3.37 Kejliet, bounded on the North by property of Mr. Saviour Cini, on the East by Zebbug Road, and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. George Vella.
2. A plot of land of the area of 6.68 Kejliet, bounded on the North by property of Mr. Emanuel Buttigieg, on the South by property of Mr. George Vella, on the East by Zebbug Road and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Saviour Cini.
3. A plot of land of the area of 1 siegh and 3.45 Kejliet, bounded on the North by property of Mr. Joseph Mangion, on the South by property of Mr. Saviour Cini, and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Emanuele Buttigieg.
4. A plot of land of the area of 2 sieghan and 2.72 Kejliet, bounded on the South and North by property of Mr. Emanuel Buttigieg, and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Joseph Mangion.
5. A plot of land of the area of 1 romna, 1 siegh and 6.8 Kejliet, bounded on the North by property of Mr. John Vella, on the South by property of Mr. Joseph Mangion, and on the East partly by Zebbug Road and partly by the remaining portion of the land of which such plot forms part; it is the property of Mr. Emanuele Buttigieg.
6. A plot of land of the area of 3.54 Kejliet, bounded on the North by property of Mr. Paul Zammit, on the South by property of Mr. Emanuele Buttigieg and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. John Vella.
7. A plot of land of the area of 9.45 Kejliet, bounded on the North by property of Mr. Luigi Calleja, on the South by property of Mr. John Vella, and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Paul Zammit.

8. A plot of land of the area of 6.83 Kejliet, bounded on the North by property of Mr. Lewis Calleja, on the South by property of Mr. Paul Zammit, and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Luigi Calleja.

9. A plot of land of the area of 2.30 Kejliet, bounded on the North by property of Mr. Anthony Zahra, on the South by property of Mr. Luigi Calleja, and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Lewis Calleja.

10. A plot of land of the area of 2.38 Kejliet, bounded on the North partly by property of Mr. Grazio Zammit and partly by property of Mr. Victor Carnemolla, on the South by property of Mr. Lewis Calleja, and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Anthony Zahra.

11. A plot of land of the area of 1.99 Kejliet, bounded on the North by property of Mr. Anthony Camilleri, on the South by property of Mr. Anthony Zahra, and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mr. Victor Carnemolla.

12. A plot of land of the area of 3.65 Kejliet, bounded on the North by property of Mr. Anthony Camilleri, on the South by property of Mr. Anthony Zahra, and on the East by property of Mr. Victor Carnemolla; it is the property of Mr. Grazio Zammit.

13. A plot of land of the area of 6.16 Kejliet, bounded on the North-West by property of Mr. Spiro Calleja, on the South by property of Mr. Grazio Zammit, and on the East and West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Anthony Camilleri.

14. A plot of land of the area of 5.34 Kejliet, bounded on the North-West by property of Mr. Paul Fiteni, on the South-East by property of Mr. Anthony Camilleri, and on the East by Zebbug Road; it is the property of Mr. Spiro Calleja.

15. A plot of land of the area of 7.29 Kejliet, bounded on the North by Government property, on the South-East by property of Mr. Spiro Calleja and on the East by Zebbug Road; it is the property of Mr. Paul Fiteni.

The abovementioned land is shown on a plan marked L.D. 318/68, which may be seen on demand at the Land Office, 29, South Street, Valletta.
