

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of fifteen plots of land at Zebbiegh, limits of Mgarr, Malta, and at Naxxar.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with the widening of the Mgarr-Zebbiegh Road; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £652. 10. 0.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 135) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Zebbiegh Limits of Mgarr, Malta, and at Naxxar.

1. A plot of land of the area of 35.76 square canes in the limits of Naxxar bounded on the North-East and North by property of the Church of All Souls of Valletta, on the West and South by Mosta-Zebbiegh Road and on the East-South-East by property of Saint Paul's Parish Church of Valletta.
2. A plot of land of the area of 127.92 square canes in the limits of Naxxar, bounded on the North and North-East by property of Saint Paul's Parish Church of Valletta, on the West, South and South-East by Mosta-Zebbiegh Road and on the West-North-West by property of the Church of All Souls of Valletta.
3. A plot of land of the area of 35.76 square canes in the limits of Mgarr, bounded on the North-East and North by Mosta-Zebbiegh Road and on the West, South and South-East by property of Mr. Carmel Sant.
4. A plot of land of the area of 44.97 square canes in the limits of Mgarr, bounded on the North-East and North by Mosta-Zebbiegh Road, on the South-West and South by property of Mr. Joseph Camilleri and on the East-South-East by property of Mr. Vincent Bonanno.
5. A plot of land of the area of 46.82 square canes in the limits of Mgarr, bounded on the North-East and North by Mosta-Zebbiegh Road, on the South-West and South by property of Mr. Vincent Bonanno and on the East-South-East by property of Mr. Carmel Vella.
6. A plot of land of the area of 33.18 square canes in the limits of Mgarr, bounded on the North-East and North by Mosta-Zebbiegh Road, on the South-West and South by property of Mr. Carmel Vella and on the West-North-West by property of Mr. Vincent Bonanno.
7. A plot of land of the area of 59.72 square canes in the limits of Mgarr, bounded on the North-East and North by Mosta-Zebbiegh Road and on the South-West and South by property of Mr. Pio Abela.

8. A plot of land of the area of 15.85 square canes in the limits of Naxxar, bounded on the West and South by Mosta-Zebbiegh Road and on the North-East and East by property of the Carmelite Priory of Mdina.

9. A plot of land of the area of 89.21 square canes in the limits of Naxxar, bounded on the West and South by Mosta-Zebbiegh Road and on the North and East by property of the Carmelite Priory of Mdina.

10. A plot of land of the area of 25.44 square canes in the limits of Mgarr, bounded on the North and East by Mosta-Zebbiegh Road and on the West and South by property of Mr. Carmelo Muscat.

11. A plot of land of the area of 154.83 square canes in the limits of Naxxar, bounded on the North and East by property of the Augustinian Friars of Rabat, Malta, on the East-South-East by property of Colonel Roger Strickland and others and on the West and South by Mosta-Zebbiegh Road.

12. A plot of land of the area of 50.87 square canes in the limits of Naxxar, bounded on the North and East by property of Colonel Roger Strickland and others, on the West-North-West by property of the Augustinian Friars of Rabat, Malta and on the West and South by Mosta-Zebbiegh Road.

13. A plot of land of the area of 20.28 square canes in the limits of Mgarr, bounded on the North and East by Mosta-Zebbiegh Road and on the West and South by property of the Augustinian Friars of Rabat, Malta.

14. A plot of land of the area of 105.43 square canes in the limits of Naxxar, bounded on the North and East by property of the Carmelite Priory of Mdina, on the South-East by property of Mr. Joseph Camilleri Berg and on the West and South by Mosta-Zebbiegh Road.

15. A plot of land of the area of 375.64 square canes in the limits of Naxxar, bounded on the North and East by property of Mr. Joseph Camilleri Berg, on the West-North-West by property of the Carmelite Priory of Mdina, on the West and South by Mosta-Zebbiegh Road.

The abovementioned land is shown on plan marked L.D. 146/70, which may be seen on demand at the Land Office, 29 South Street, Valletta.
