

MEMORANDUM BY THE MINISTER OF JUSTICE  
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of nine plots of land at Zebbug Malta.

Since this land is required by the Government only during the construction of a bridge, it is proposed to acquire it under Possession and Use terms.

The above plots of land are required by the Government in connection with the construction of a bridge on the new Zebbug-Siggiewi Road; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total acquisition rent for the above plots of land amounts to £23. 17. 3. yearly.

The said Declaration supersedes that referred to Cabinet on the 6th November, 1970.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be for the Possession and Use thereof for such time as the exigencies of the public purpose require.

Description of the land  
-----

The following land at Zebbug, Malta:-

1. A plot of land of the area of 147.6 square canes, bounded on the East and West by property of Reverend Joseph Galea, and on the North-North-East by a public road.
2. A plot of land of the area of 66.7 square canes, bounded on the West by property of Reverend Joseph Galea, and on the South and East by a public road.
3. A plot of land of the area of 93.1 square canes, bounded on the West and East by property of Mr. Salvatore Vassallo, and on the North-North-East by a public road.
4. A plot of land of the area of 121.1 square canes, bounded on the West and East by property of Mr. Gaudenz Magro, and on the South-South-West by a public road.
5. A plot of land of the area of 127 square canes, bounded on the West and East by property of Mr. Guadenz Magro, and on the South-South-West by a public road.
6. A plot of land of the area of 71.9 square canes, bounded on the West and East by property of Mr. Carmelo Agius and on the North-North-East by a public road.
7. A plot of land of the area of 94.2 square canes, bounded on the West and East by property of Mr. Carmelo Agius and on the North-North-East by a public road.
8. A plot of land of the area of 118 square canes, bounded on the West and South by property of Mrs. Miriam Muscat, and on the East by Government property.
9. A plot of land of the area of 99 square canes, bounded on the East and South by property of Mrs Miriam Muscat, and on the West by Government property.

The above mentioned land is shown on plan marked L.D. 186A/70, which may be seen on demand at the Land Office 29, South Street Valletta.
