MEMORANDUM BY THE MINISTER OF JUSTICE AND PURLIAMENTARY AFFAIRS

Agricultural Leases (Reletting) Act, 1967

The attached draft Declaration by His Excellency the Governor-General refers to the termination of the lease of seventeen (17) agricultural plots of land in the limits of Gudja and Kirkop.

This agricultural land, which belongs to the Government is required for a public purpose, namely for the extension of the Luqa Runway; consequently, the attached Declaration will be signed by His Excellency the Governor-General in accordance with the provisions of subsection (1) of section 20 of the Agricultural Leases (Reletting) Act. 1967.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land owned by Government is required for a public purpose in accordance with the provisions of the Agricultural Leases (Reletting) Act, 1967.

Description of the Land

The following land in the limits of Gudja and Kirkop:

- 1. A plot of land in the limits of Kirkop of the area of approximately 20 Tumcli 3 Sieghan 8 Kejliet (23194 square metres), bounded on the North and East by Government property and on the West and South by a public road and shown on Government Records as Rural Tenement No. 75.
- 2. A plot of land in the limits of Kirkop of the area of approximately 4 tumoli 5 Sieghan 2 Rejliet (5471 square metres), bounded on the North-East and South by a public road and on the lest by Government property, and shown on Government Records as Rural Tenement No. 1474.
- 3. A plot of land in the limits of Kirkop of the area of approximately 8 Tumoli 1 Siegh 3 Rejliet (9237 square metres), bounded on the North by public road, on the est and South by Government property, and shown on Government Records as Rural Tenement No. 1520.

- 6. A plot of land in the limits of Kirkop of the area of approximately 2 Tumoli 1 Siegh (2436 square metres), bounded on the North, East and South by property of the Archiepiscopal Curia and on the West by an alley and shwon on Government Records as Rural Tenement No. 1534.
- 7. A plot of land in the limits of Kirkop of the area of approximately 3 Tumoli 2 Sieghan 3 Kejliet (3803 square metres), bounded on the North-West by an alley,

om the North-East by property of the Archiepiscopal Curia and on the South-East and South-West by Government property and shown on Government Records as Rural Tenement No. 1512.

- 8. A plot of land in the limits of Kirkop of the area of approximately 4 Tumoli 3 Sieghan 8 Kejliet (5208 square metres), bounded on the North-West and South-West by Government property and on the South-East by an alley and shown on Government Records as Rural Tenement No. 1519.
- 9. A plot of land in the limits of Kirkop crossed by a road having an area of approximately 5 Tumoli 0 Sieghan 1 Kejliet (5639 square metres) bounded on the North-West by property of the Archiepiscopal Curia, on the South-West and South-East by Government property and shown on Government Records as Rural Tenement No. 1528.
- 10. A plot of land in the limits of Kirkop of the area of approximately 2 Tumoli 0 Sieghan 7 Kejliet (2379 square metres) bounded on the North-West, South and South-East by Government property and shown on Government Records as Rural Tenement No. 1526.
- of approximately 11 Tumoli 1 Siegh 8 Kejliet (12703 square metres) bounded on the North by a public road, on the East partly by Government property and partly by property of the Archiepiscopal Curia and on the South by property of the Archiepiscopal Curia and shown on Government Records as Eural Tenement No. 1530.
- 12. A plot of land in the limits of Kirkop of the area of approximately 11 Tumoli 5 Sieghan 4 Kejliet (13377 square metres) bounded on the South by a public road on the North partly by Government property and partly by property of the Archiepiscopal Curia and on the East by Government property and shown on Government Records as Rural Tenement No. 1536.
- 13. A plot of land in the limits of Kirkop of the area of approximately 1 Tumoli O Sieghan 6 Kejliet (1237 square metres), bounded on the West and South-East by property held on temporary emphyteusis by Government and on the North by Government property and shown on Government Records as Rural Tenement No. 1525.
- 14. A plot of land in the limits of Kirkop of the area of approximately 5 Tumoli 1 Siegh 5 Kejliet (5902 square metres), bounded on the West by property of the Archiepiscopal Curia, on the North-East by property held on temporary emphyteusis by Government and on the South by Government property and shown on Government Records as Rural Tenement No. 1529.

15. A plot of land in the limits of Kirkop of the area of approximately 4 Tumoli 2 Sieghan 1 Kejla (4890 square metres) bounded on the North by a public road, on the West by Government property and on the South by property of the Archiepiscopal Curia and shown on Government Records as Rural Tenement No. 1535.

16. A plot of land partly in the limits of Kirkop and partly in the limits of Gudja, crossed by a road of the area of approximately 16 Tumoli 1 Siegh 4 Kejliet (18248 square metres) bounded on the North-East by property of the Archiepiscopal Curia, on the North-West and East by Government property and shown on Government Records as Rural Tenement No. 1527.

17. A plot of land in the limits of Gudja of the area of approximately 3 Tumoli 4 Sieghan 1 Kejla (4141 square metres) bounded on the North-East and South-East by property of the Archiepiscopal Curia and on the West by Government property and shown on Government Records as Rural Tenement No. 1513.

The abovementioned land is shown on plan marked L.D. 124B/72 which may be seen on demand at the Land Office, 29, South Street, Valletta.
