

MEMORANDUM BY THE ACTING MINISTER OF JUSTICE

Land Acquisition (Public Purposes) Ordinance, Cap. 136

The attached Declaration by His Excellency the Governor-General deals with the acquisition of eighteen plots of land in the limits of Naxxar. It is proposed to acquire by outright purchase and the land in question is required for a Public Purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

The acquisition under review is inherent to the construction of a new road from Mosta to Naxxar.

No immovable structures are involved in the project.

It emerges from the valuation report by the Land Engineer that the freehold value of the plots amounts to £7,885. 2sh. 9d.

Hon. members are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purpose) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Haxxar.

1. A plot of land of the area of 3 Sieghan and 2.8 kejllet, bounded on the North-West by Mosta Road, on the East by the property of Reverend Father Salvatore Scicluna and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Marchese John Scicluna.

2. A plot of land of the area of 1 Tomna, 2 Sieghan and 8.8 Kejllet bounded on the North-West by Mosta Road, on the West by the property of Marchese John Scicluna and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Reverend Father Salvatore Scicluna.

3. A plot of land of the area of 4 Sieghan and 8.55 Kejllet, bounded on the West by property of the Reverend Father Salvatore Scicluna, on the East by a lane and on the North and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mrs Carmela Dimech and others.

4. A plot of land of the area of 3 Sieghan and 6.23 Kejllet, bounded on the West by a lane, on the East by another lane and on the North and on the

South by the remaining portion of the land of which such plot forms part; it is the property of Mr Joseph Vella.

5. A plot of land of the area of 3 Sieghan and 7.54 Kejllet, bounded on the West by a lane, on the South-East by the property of Mr Joseph Camilleri and on the North and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Peter Farrugia.

6. A plot of land of the area of 3 Sieghan and 6.3 Kejllet, bounded on the North-West by the property of Mr Peter Farrugia, on the North-East by the property of Mr Salvatore Camilleri and on the North and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Joseph Camilleri.

7. A plot of land of the area of 3 Sieghan and 4 Kejllet, bounded on the South-West by the property of Mr Joseph Camilleri, on the East by an Alley and on the North and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mr Salvatore Camilleri.

8. A plot of land of the area of 3 Sieghan and 5.7 Kejllet, bounded on the West by an Alley, on the North-East by the property of Mr Nikol Bonavia and on the North and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Reverend Father Salvatore Scicluna.

9. A plot of land of the area of 5 Sieghan and 6.8 Kejllet, bounded on the South-West by the property of the Reverend Father Salvatore Scicluna, on the East by the property of the Reverend Father Paul Said and on the North and on the South by the remaining portion of land of which such plot forms part; it is the property of Mr Nikol Bonavia.

10. A plot of land of the area of 3 Sieghan and 6.7 Kejliet, bounded on the West by the property of Mr Nikol Bonavia, on the North-East by the property of Mrs Carmela Stivala and on the North and South by the remaining portion of the land of which such plot forms part; it is the property of the Reverend Father Paul Said.

11. A plot of land of the area of 1 Siegh and 4.4 Kejliet, bounded on the South-West by the property of the Reverend Father Paul Said on the South-East by the property of Mrs Nazzena Bonavia and on the North by the remaining portion of the land of which such plot forms part; it is the property of Mrs Carmela Stivala.

12. A plot of land of the area of 1 Siegh and 8 Kejliet, bounded on the North-East and on the North-West by the property of Mrs Carmela Stivala and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mrs Nazzena Bonavia.

13. A plot of land of the area of 3 Sieghan, bounded on the South-West and on the North-East by the property of Mrs Nazzena Bonavia and on the North and on the South by the remaining portion of the land of which such plot forms part; it is the property of Mrs Carmela Stivala and others.

14. A plot of land of the area of 1 Siegh and 0.3 Kejliet, bounded on the South and on the South-West by the property of Mrs Carmela Stivala and others, on the East partly by the property of Mr Angelo Gauci and partly by the property of Mr Joseph Deguara, and on the North by the remaining portion of the land of which such plot forms part; it is the property of Mrs Nazzena Bonavia.

15. A plot of land of the area of 1 Siegh

and 5.76 Kejliet, bounded on the West partly by the property of Mrs Nazzarena Bonavia and partly by the property of Mr Joseph Deguara, on the East by an Alley and on the North partly by an Alley and partly by the remaining portion of the land of which such plot forms part; it is the property of Mr Angelo Gauci.

16. A plot of land of the area of 2.4 Kejliet, bounded on the North, on the South and on the East by the property of Mr Angelo Gauci and on the West by the property of Mrs Nazzarena Bonavia; it is the property of Mr Joseph Deguara.

17. A plot of land of the area of 1 Siegh and 4.6 Kejliet, bounded on the West by an Alley on the North-East by Żenqa Street and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Noble Baron Galea Testaferrata.

18. A plot of land of the area of 4 Sieghan and 3.27 Kejliet, bounded on the South-East by Labour Road, and on the South and on the South-West by Government property, it is the property of the Most Noble Count Alfred Sant Fournier and others.

The above mentioned land is shown on a plan marked L.D.150/64 which may be seen on demand at the Land Office, 29, South Street, Valletta.
