MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of six premises at Mqabba.

Since these premises are permanently required by the Government, it is proposed to acquire them by absolute purchase.

The above premises are required by the Government in connection with the opening of an approach road to Church Square, Mqabba; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above premises amounts to £4480..0..0d.

Honourable Ministers are invited to recommend.

Part of premises Nos. 17 and 18, Church Square, consisting of part of a small room of the area of 88 square feet, at ground floor level having a door No. 18 abutting on Church Square, and of part of the overlying room at first floor level of the area of 88 square feet, bounded on the North and West by Church Square, on the South-West by property of Mr. Grazio Zammit, and on the South-East by property of Mr. Joseph Farrugia.
