

## MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY AFFAIRS

### Land Acquisition (Fublic Furposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of nine plots of land at St. Julians.

bince this 1 nd is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with the construction of the Sliema Regional Road; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to 2282.14.10d.

Honourable Ministers are invited to recommend.
