

Memorandum for the Cabinet
by the Hon. Minister of Justice

Land Acquisition (Public Purposes) Ordinance, Cap. 136.

It is proposed to acquire nine plots of land at Zurrieq described in the attached Declaration. The land is required in connection with the construction of a Bypass to Zurrieq and it is, therefore, obvious that the acquisition is being made for a public purpose.

Hon. Members are invited to recommend.

DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following 9 plots of land at Zurrieq:-

1. A plot of land of the area of 4 Sieghan and 6 Kejliet, bounded on the North-North-East by Qrendi Road, on the West-South-West by property of Mr. Joseph Darmanin and on the North-West and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of the Qrendi Parish Church.

2. A plot of land of the area of 2 Sieghan and 7 Kejliet, bounded on the East-North-East by property of the Qrendi Parish Church, on the South-South-East partly by property of Saura Hospital and partly by Government property, and on the North-West and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of Mr. Joseph Darmanin.

3. A plot of land of the area of 1 Siegh and 1 Kejla, bounded on the North-North-West by property of Mr. Joseph Darmanin, on the South-West by property of the Zurrieq Parish Church and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of Saura Hospital.

4. A plot of land of the area of 4 Sieghan, bounded on the East-North-East by property of Saura Hospital, on the West by property of Mr. C. Camilleri and on the North-West and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of the Zurrieq Parish Church.

5. A plot of land of the area of 1 Siegh and 9.5 Kejliet, bounded on the East by property of the Zurrieq Parish Church, on the South-West by property of Miss Catherine Caruana and on the North-West and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of Mr. Carmel Camilleri.

6. A plot of land of the area of 4 Sieghan and 4 Kejliet bounded on the North-East by property of Mr. Carmel Camilleri; on the South-West partly by property of the Zurrieq Parish Church and partly by property of

Mr. Saviour/.....

Mr. Saviour Vella; and on the North-West and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of Miss Catherine Caruana.

7. A plot of land of the area of 1 Siegh and 6.5 Kejllet, bounded on the North-East by property of Miss Catherine Caruana on the South-West by property of the Archiepiscopal Curia, on the North-West by property of the Zurrieq Parish Church and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of Mr. Saviour Vella.

8. A plot of land of the area of 1 Siegh and 5.4 Kejllet, bounded on the North-East by property of Miss Catherine Caruana; on the South-West by property of the Archiepiscopal Curia and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of the Zurrieq Parish Church.

9. A plot of land of the area of 1 Tonna 4 Sieghan and 7.9 Kejllet, bounded on the North-East partly by property of the Zurrieq Parish Church and partly by property of Mr. Saviour Vella, on the South by Wied iz-Zurrieq Road and on the North-West and on the South-East by the remaining portion of the land of which such plot forms part; it is the property of the Zurrieq Parish Church.

The abovementioned land is shown on plan marked L.D. 87/63 which may be seen on demand at the Land Office, 29, South Street, Valletta.

This declaration supersedes that published by Government Notice No. 617 dated 9th November, 1955: the plots or parts of plots (except plots Nos. 2 and 6 already purchased by Government) comprised in the latter declaration and which are not included in the present declaration are no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.
