MEMO FOR THE CABINET BY THE HON.MINISTER OF JUSTICE

LAND ACQUISITION (PUBLIC PURPOSES) ORDINANCE, CAP. 136

It is proposed to acquire the immovable property listed under thirteen items in the attached Declaration. The object of the acquisition is the implementation of a planning scheme for Zurrieq which will also improve the approaches of the Parish Church. The acquisition is, obviously, being made for a public purpose.

Hon. Members are invited to recommend.

DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Zurrieq:-

- l. A plot of land having an area of 811.5 square canes forming part of the back gardens of premises No. 76, Queen Street, bounded on the North-West by property of Mrs Catherine Camilleri, on the North-North-West, and on the East-North-East by property of Mr Giuseppe Attard, and on the East-South-East by property of the Rev. Prof. Peter Paul Saydon and by property of Rev. Giuseppe Zammit Falzon, and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr Emmanuel Duca.
- 2. A plot of land, including a room and a loft underlying part of premises Nos. 13/14, Britannia Street, having an area of 63.4 square canes being the back garden of premises No. 12, Britannia Street, bounded on the North by property of Mr Francis Bugeja, on the West by property of Mr Giuseppe Attard and on the South-South-East by property of Mr Emmanuel Duca; it is the property of Mrs Catherine Camilleri.
- 3. A plot of land having an area of 9.2 square cames forming part of garden at No. 96, Britannia Street, bounded on the South by Britannia Street, on the East by property of Zurrieq Parish Church, and on the North and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr Angelo Ellul as regards the Utile Dominium and of the Zurrieq Parish Church as regards the Directum Dominium.
- 4. A plot of land having an area of 1 Tomna, 1 Siegh and 5 Kejlie, bounded on the South by property of the

Zurrieq Parish Church, on the East partly by property of Mr Vincenzo Zerafa in course of acquisition by Government, and partly by property of Mr Giuseppe Abdilla, and on the North partly by property of Mr Alfred Delia and partly by property of Mr Grazzio Ebejer, and on the West by the remaining portion of the land of which such plot forms part; it is the property of the heirs of Mr J. Zammit L.P.

- 5. A plot of land having an area of 1 Biegh and 3.5 Kejliet, bounded on the South by property of Mr Vincenzo Zerafa in course of acquisition by Government, on the West by property of the heirs of Mr J. Zammit L.P. and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mr Giuseppe Abdilla.
- 6. A plot of land having an area of 7.3 kejliet bounded on the South by property of the heirs of Mr J. Zammit L.P., on the East by property of Mr Grazzio Ebejer, and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr Alfred Delia.
- 7. A plot of land having an area of 1 Siegh and 9
 Kejliet bounded on the West by property of Mr Alfred Delia,
 on the South partly by property of the heirs of Mr J. Zammit
 L.P. and partly by property of Mr Giuseppe Abdilla, and on
 the North and on the East by the remaining portion of the
 land of which such plot forms part; it is the property of
 Mr Grazzio Ebejer.
- 8. Premises Nos. 97/98 and 99, Brittannia Street and a plot of land including an alley having an area of 4 Sieghan and 7.7 Kejliet, bounded on the East by property of Mr Vincenzo Zerafa in the course of acquisition by Government, on the North by property of the heirs of Mr J. Zammit L.P. and on the West partly by property of Mr Angelo Ellul and partly by the remaining portion of the land of which such plot forms part; it is the property of the Zurrieq Parish Church.

- 9. Premises Nos. 13/14, Brittania Street; property of Mr Francis Bugeja.
- 10. Premises No. 15, Britannia Street; property of Mrs Giuseppa Attard.
- 11. Premises Nos. 16/17, Britannia Street; property of Mrs Giuseppa Attard.
- 12. Premises Nos. 18/19, Britannia Street; property of Mr Francis D'Amato.
- 13. Premises No. 20, Britannia Street; property of Mr Victor Schembri.
