

Memorandum for the Cabinet  
by the Hon. Minister of Justice

Land Acquisition (Public Purposes) Ordinance, Cap.136

It is proposed to acquire 23 plots of land and buildings at Rabat described in the attached Declaration. The land is required in connection with the Project for the reconstruction of St. Paul's Church Area. The acquisition is required for a public purpose.

DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

23. A Farmhouse at "Il-Foss", Victory Street, (including the enjoyment of a right of way over the adjoining property to Emmanuel Vitale Street), bounded on the North-East by Victory Street, on the South-East by property of Ta' Saura Institute and on the North-West by the remaining portion of the land of which it forms part; it is the property of Mrs. Vincenza Bugeja.
