

MEMORANDUM BY THE MINISTER OF JUSTICE

Land Acquisition (Public Purposes) Ordinance Chapter 136

The attached Declaration is related to a reconstruction project connected with the Qrendi Scheme.

It is proposed to execute the project in two phases. The property specified in the Declaration is inherent to the execution of the first phase. The acquisition thereof is to be effected by absolute *purchase*.

The acquisition is for a public purpose in terms of the Land Acquisition (Public Purposes) Ordinance Chapter 136.

DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Qrendi:-

1. Premises No. 45, Parish Street, property of Mr. Nicholas Camilleri.
2. Premises No. 46, Parish Street and part of premises Nos. 75/76, Main Street, consisting in a part of a large room having a door No. 76 Main Street and part of a yard accessible from said room and having an area of 4.7 square canes together with part of the garden of the abovementioned premises having an area of 137 square canes and bounded on the West by Parish Street, on the West-North-West, on the North-East, on the North-North-East and on the South-East by the abovementioned premises of which it forms part; they are the property of Mr J. Camilleri and others.
3. Premises No. 77, Main Street, and part of the garden of said premises having an area of 32 square canes and bounded on the East by property of the Rev. Nicholas Mifsud and others, on the North-West by property of Mr. J. Camilleri and others and on the South-West by the remaining portion of the garden of which it forms part; it is the property of Mr. J. Camilleri and others.
4. Part of premises No. 78, Main Street, consisting in part of a room at ground floor, part of a room at first floor, part of the stairs, part of the yard, a room in the yard and another part of a room accessible from the yard, together, having an area of 16 square canes and bounded on the South-East by Main Street, on the South-West by property of Mr. J. Camilleri and others and on the North-North-East by the remaining part of the premises of which it forms part; it is the property of

5. Part of the garden of premises No. 79, Main Street, having an area of 8 square canes and bounded on the West-South-West and on the South-East by property of Mr. J. Camilleri and others and on the North-North-East by the remaining portion of the garden of which it forms part; it is the property of Rev. Nicholas Mifsud and others.

The above-mentioned land is shown on plan marked L.D. 135/63 which may be seen on demand at the Land Office, 29 South Street, Valletta.
