Memorandum by the Minister of Justice

Land Acquisition (Public Purposes) Ordinance

(Chapter 136).

The attached Declaration by His Excellency the Governor covers eleven plots situated at Naxxar.

The proposed acquisition is to be effected by way of absolute purchase. The eleven plots are required for the widening of San Pawl tat-Targa Road, and therefore, for a public purpose in accordance with the provisions of the Land Acquisition (Public purposes) Ordinance (Chapter 136).

Apart from a farmhouse, a part of another farmhouse and two garages the acquisition does not involve any immovable structure.

It emerges from the valuation report by the Land engineer the freehold value of the eleven plots have been assessed at £2,793. 3. 4d.

## DECLARATION BY THE GOVERNOR

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

## Description of the Land

## The following band at Naxxar:-

- l, A plot of land of the area of 1.6 Kejliet bounded on the West by property of Rev. Saviour Scicluna, on the South-West by San Pawl tat-Targa Road and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of the legacy founded by Dr. Carlo Perton.
- 2. A plot of land of the area of 2 Sieghan and 6.5 Kejliet including farmhouse No. 50 and two garages one unnumbered and the other No. 51, San Pawl tat-Targa Road, altogether bounded on the Mast by property of the legacy founded by Dr. Carlo Perton, on the North and on the North-West by property of Miss María A. Galea on the South-West by San Pawl tat-Targa Road and on the North-Mast and on the South-Mast by the remaining portion of the property of which the said land forms part; it is the property of the Reverend Savious Scicluma.
- 3. A plot of land of the area of 1 siegh and 3 Kejliet bounded on the South and on the South-Hast by property of Rev. Saviour Scicluma, on the West by San Pawl tat-Targa Road and on the North-Hast and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of Miss Maria A. Gale.
- 4. A plot of land of the area of 1.1 Rejliet bounded on the North-Jest by property of Fantino Borg and others, on the South-Jest by San Pawl tat-Targa Road and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Miss Maria A. Galea.

- 5. A plot of land of the area of 6.4 Kejliet, bounded on the South-East by property of Miss maria A. Galea, on the North-West by property of Santa Lucia Church of Naxxar, on the South-West by San Pawl tat-Targa Road and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Mr. Fantino Borg and others.
- 6. A plot of land of the area of 9.6 Kejliet bounded on the South-East by property of Mr. Fantino Borg and others, on the North-est by property of Mr. Paul Schembri, on the South-West by San Pawl tat-Targa Road and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Santa Lucia Church of Naxxar.
- 7. A plot of land of the area of 7.9 Kejliet bounded on the South-East by property of Santa Lucia Church of Naxxar, on the North-West by property of Mr. J. B. Francia, on the South-West by San Pawl tat-Targa Road and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Mr. Paul Schembri.
- 8. A plot of land of the area of 8.3 Kejliet bounded on the South-East by property of Mr. Paul Schembri, on the North-West by property of Mr. Fantino Borg and others, on the South-West by San Pawl tat-Targa Road and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Mr. J. B. Francia.
- 9. A plot of land of the area of 1 Siegh and 1 Kejla bounded on the South-East by property of Mr. J. B. Francia, on the South-West by San Pawl tat-Targa Road and on the North-East by the remaining portion of the land of which such plot forms part; it is the property of Fantino Borg and others.
- 10. A plot of land of the area of 2 Sieghan and 4.3 Kejliet including part of a farmhouse bounded on the South-East by property of Mr. Anthony Agius on the North-East and on the North-East by San Pawl tat-

Targa Road and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of the Jesuits of Naxxar.

ll. A plot of land of the area of 2.2 Kejliet bounded on the North-West by property of the Jesuits of Naxxar on the North-East by San Pawl tat-Targa Road and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of Mr. Anthony Agius.
