Memorandum by the Minister of Justice Land Acquisition (Public Purposes) Ordinance, Cap. 136

The attached Declaration by His Excellency the Governor-General covers sixteen plots of land at Siggiewi.

It is proposed to acquire by title of absolute purchase.

The land is being acquired by Government for the purpose of widening Providenza Road. It is therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance, Cap. 136.

The Land Engineer in his report has assessed the freehold value of the property in question at £308.11s.7d. No consideration has been taken in this valuation in respect of rural rooms and wells existing in the land under review since these are being reconstructed by the Public Works Department on the residual sites.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

- 13. A plot of land of the area of 6.6 kejliet, bounded on the West by Providenza Road, on the North-West by the property of Mr Angelo Schembri and on the East by the remaining portion of the land of which such plot forms part; it is the property of Mr Paul Bonello.
- bounded on the East by Providenza Road, on the South-South-East by property of Mr Michael Schembri and on the Mest by the remaining portion of the land of which such plot forms part; it is the property of Dr. A. Stilon Depiro LL.D.
- 2.2 kejliet, bounded on the East, on the North-East and on the South-East by Providenza Road and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr Michael Schembri.
 - 16. A plot of land of the area of 7.8 kejliet, bounded on the North by property of Mr Michael Schembri, on the East by Providenza Road and on the West by the remaining portion of the land of which such plot forms part; it is the property of Mr Paul Bonello.
