

Memorandum by the Minister of Justice  
Land Acquisition (Public Purposes) Ordinance  
Chapter 136

The attached Declaration by His Excellency the Governor-General covers seven plots of land within the limits of Lija.

It is proposed to acquire by title of absolute purchase.

The proposed acquisition arose from the necessity of widening L-Eklin Road at Lija. No immovable structures are involved in the proposed acquisition. The project aims at rounding off dangerous corners and road widening.

The acquisition is for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance Chapter 136.

It transpires from the report of the Land Engineer that the freehold value of the seven plots under review amounts to £173.0s.0d.

Honorable Ministers are solicited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Lija:

1. A plot of land of the area of 7.68 kejliet, bounded on the South-East and on the East by L-Iklin Road, and on the West by the remaining portion of the land of which this plot forms part; it is the property of the Most Noble Count Bernardino Manduca Piscopo Macedonia Zamait.

2. A plot of land of the area of 2.53 kejliet, bounded on the West and on the North-West by L-Iklin Road, on the East by property of Mr Joseph Lombardi and on the South-East by the remaining portion of the land of which this plot forms part; it is the property of Mrs Maria Stella Briffa.

3. A plot of land of the area of 8.38 kejliet, bounded on the West by property of Mrs Maria Stella Briffa, on the North-West, on the North and on the North-East by L-Inklin Road and on the South by the remaining portion of the land of which this plot forms part; it is the property of Mr Joseph Lombardi.

4. A plot of land of the area of 1.22 kejliet, bounded on the South-West by L-Inklin Road, on the East by property of unknown owners and on the North by the remaining portion of the land of which this plot forms part; it is the property of "Beneficcju San Mikiel Arkanġlu".

5. A plot of land of the area of 6.7 kejllet, bounded on the West by property of the "Beneficcju San Mikiel Arkanglu" on the South-West, on the South and on the South-East by L-Iklin Road and on the North by the remaining portion of the land of which this plot forms part; it is the property of unknown owners.

6. A plot of land of the area of 4.2 kejllet, bounded on the North-West on the North and on the North-East by L-Iklin Road, and on the South by the remaining portion of the land of which this plot forms part; it is the property of Mrs Mary Attard Montalto.

7. A plot of land of the area of 1 slegħ and 4 kejllet, bounded on the South and on the East by L-Iklin Road and on the North-West and on the South-East by the remaining portion of the land of which this plot forms part; it is the property of unknown owners.

The above mentioned land is shown on a plan marked L.D. 111/65 which may be seen on request at the Land Office, 29, South Street, Valletta.
