
Trade Agreement between Malta and Japan

In August 1965 talks had taken place between representatives of the Government of Molta and representatives of the Government of Japan in connection with the conclusion of a Trade Agreement between the two countries.

During these talks representatives of several different Ministries/Departments formed part of the Maltese delegation. These were: Ministry of Industrial Development and Tourism (Foreign Trade Relations Division), Ministry of Commonwealth and Poreign Affairs, Ministry of Economic Planning and Finance, Customs and Port Department and the Department of Agriculture.

At the close of the discussions, agreement between the two sides had been reached on all points in the Draft as specified in Annex "A" except for the following:

(a) Article 2: The Japanese Delogation wished to delete this article since the relative exceptions are covered by the reference to GATT in Article 1. The GATT envisages such preference and participations and has approved the current Commonwealth Preferences and permits the formation of and the perticipation in Free Trade Areas and Customs Unions. The Maltese Delegation agreed with this contention but felt that the exclusion of this Article in the Agreement might jeopardise Malta's ease of movement in the future. The Maltese Delegation offered to accept the inclusion of "within the framework of GATT" between "grant" and "to" in the third and fourth lines. They were also agreeable to accept the provision via an exchange of letters.



(c) Article 5: Notwithstanding agreement of the actual wording, the Maltese Delegation wished to have further consultations with their Government. The Japanese Delegation stated that they wished this Article to be included, first because it had been formally suggested by Malta itself to Japan and secondly because it was their practice to include such provision in Trade Agreements with other countries.

Agreement was also reached on excharge of letters as per Annexes B, C, D, E, F. Agreement on Annex "G" is conditional to agreement being reached on Article 3.

It was consequently agreed between the two delegations that before continuing with the talks, both sides thought it necessary to refer the disagreed points to their respective Government. A joint communique was issued to this effect.

This Ministry has now been informed that the Japanese Government have given instructions to their Embersy in Rome to proceed with the talks for the purpose of concluding a Trade Agreement between the two countries.

The most important point, as regards Malta, concerns
Article 3 in respect of which the Maltese Delegation had
insisted that it should be supplemented by an exchange of
letters to bring out Japan's willingness to consider
favourably requests for economic and technical cooperation
in respect of mutually agreed projects. Since the Japanese

Government have taken the initiative to request the resumption of the talks it is safe to assume that they are prepared to meet Malta's wishes in this regard.

In the light of what has been stated earlier in this Memorandum, Hon. Ministers are asked to give their approval to the following:-

- That discussions between Maltese and Japanese representatives be resumed;
- 2. That Mr A. Wirth, Secretary to the Ministry of Trade, Industry and Agriculture, be authorised to represent the Government of Halta for the purpose of the discussions, the initialling of the Trade Agreement and the signing of same (this authority to be availed of in the event of the Japanese representative being invested with similar powers.)
- 3. That the draft Trade Agreement at Annex "A" should serve as a basis of discussions subject to the following:
 - (i) Article 2 to be deleted;
 - (ii) Article 5 to be retained;
- (iii) Article 3 to be supplemented by an exchange of letters on the lines of Annex "G".
- 4. That concurrently with the signing of the Trade Agreement, Malta disinvokes Article XXXV of GATT in relation to Japan and takes inwediate action to inform the Director General of GATT to this effect (Annex "B").
- 5. That Annexes C, D, E and F should form part of the Trade Agreement.

THADE AGREEMENT BETWEEN MALTA AND JAPAN

The Government of Malta and the Government of Japan, in their desire to expand and streng hen the trade relations between their two countries, have agreed as follows:

Article 1

The Government of Malta and the Government of Japan undertake to improve in every possible way existing mutual trade relations.

In order to promote and facilitate trade between Malte and Japan, the Government of each country will grant the most-favoured-nation treatment in respect of trade between the two countries in accordance with the rights and obligations which each country has or may have as a Contracting Party to the General Agreement on Tariffs and Trade.

Article 2

The provisions of Article 1 above shall not extend to advantages, concessions and exemptions which either of the Contracting Parties grant or will grant to states participating in a Customs Union, in a Customs Preference System or in a Free Trade Area already in existence or which may be established in the future.

Article 3

With a view to contributing to the economic and social development of their respective countries, the two Contraction Parties shall endeavour to find the appropriate form of economic and technical cooperation between the two countries.

Article 4

All payments between the two countries shell be effected in pounds sterling or in other freely convertible currencies within the scope of the lews and regulations of the respective countries.

Article 5

A Mixed Commission will be formed which shall meet of the request of either side and, if possible, on the suggested date. It will be the function of the Mixed Commission to clarify any questions or problems which may arise in the carrying out of this Agreement. This Mixed Commission will be composed of representatives of both Governments.

Article 6

The two Contracting Parties shall, subject to the Juwe and regulations in force in their respective country, exempt from customs duties articles destined for Feirs and Exhibitions as well as samples of goods for advertising purposes provided that such articles and samples shall not be disposed of without the prior permission of the competent

authorities of the importing country and the payment of the appropriate customs duties.

Article 7

This Agreement shall come into force on signature. It shall be valid for one year and shall thereafter be automatically renewed from year to year unless written notice of termination is given by one contracting party to the other at least three months in odvance.
