MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY AFFAIRS.

Land Acquisition (Public Purposes) Ordinance (Chapter 136).

The attached Declaration by His Excellency the Governor-General refers to 24 plots of land at St. Julian's.

Since these plots of land are permanently required by the Government, it is proposed to acquire them by absolute purchase.

These plots are required by the Government in connection with the construction of the third phase of the Sliema Regional Road; they are therefore required by a public purpose in accordance with the provisions of the Land Acquisition (Fublic Purposes) Ordinance (Chapter 136).

From the reports submitted by the Land Engineer it transpires that the total freehold value of the plots (part of which have been declared frozen by an order made under the Special Development Areas Act, 1956, and published on the 24th November, 1961) amounts to £4,247.19.2.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

- 12. A plot of land of the area of 4 sieghen and 3.3 kejliet, bounded on the North by property of Mr. Carmelo Pirotta, on the South by property of Mr. Grazzio Caruana and on the East by Government property; it is the property of Mr. Julian Grech.



- 13. A plot of land of the area of 1 tomna and 5 kejliet, bounded on the North by property of Mr. Albert Debono and others, on the South by property of Mr. Julian Grech and on the East by Government property, it is the property of Mr. Carmelo Pirotta.
- 14. A plot of land of the area of 2 sieghan and 5 kejliet, bounded on the North by property of Mr. Carlo Borg on the South by property of Mr. Carmelo Firotta and on the East by Government property; it is the property of Mr. Albert Debono and others.
- 15. A plot of land of the area of 7.5 kejliet, bounded on the North-East by Government property, on the bouth by property of Mr. Albert Debone and others and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. Carlo Borg.
- 16. A plot of land of the area of 1 towns 1 siegh and 4 kejliet bounded on the North by property of Mr. Paul Spiteri, on the South by Government property and on the East by the remaining portion of the land of which this plot forms part; it is the property of Mr. Anthony Abdilla.
- 17. A plot of land of the area of 1 siegh and 7.3 kelliet, bounded on the North by a public road, on the South by property of Mr. Anthony Abdilla and on the East by the remaining portion of the land of which this plot forms part; it is the property of Mr. Paul Spiteri.
- 18. A plot of land of the area of 3 sieghan and 2.6 kejliet, bounded on the North by property of Mr. Albert Debono, on the South by the public read and on the East by the remaining portion of the land of which this plot forms part; it is the property of Mr. Alfred Camilleri and others.
- 19. A plot of land of the area of 3 sieghan and 8.5 kejliet, bounded on the North-East by property of Mr.Carlo.. Debono and others, on the South by property of Mr. Alfred Camilleri and others and on the West by the remaining portion of the land of which this plot forms part; it is property of Mr. Albert Debono
- 20. A plot of land of the area of 3 sieghan and 9.7 kejliet, bounded on the Bouth by property of Mr. Albert Debono and on the East and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr. Carlo Debono and others.

- and 9.1 kejliet, bounded on the South partly by property of Mr. John Mamo and others and partly by property of Messrs England and England, on the West by property of Mr. Francis Mamo and on the East by the remaining portion of the land of which this plot forms part; it is the property of Dr. Joseph Vella LL.D.
- 23. A plot of land of the area of 2 sieghan and 1.9 kejliet, bounded on the West by property of Dr. Joseph Vella LL.D. and on the North and on the East by the remaining portion of the land of which this plot forms part; it is the property of Messrs England and England.
- 24. A plot of land of the area of 1 towns 2 sieghan and 5.9 kejliet, bounded on the North, on the South and on the East by property of Dr. Joseph Vella LL.D., and on the West by the remaining portion of the land of which this plot forms part; it is the property of Hr. Francis Mamo.
