MEMORANDUM BY THE MINISTER OF JUSTICE AND FARLIAMENTARY AFFAIRS.

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of four plots of land at Rabat, Gozo.

Since these plots of land are permanently required by the Government, it is proposed to acquire them by absolute purchase.

These four plots of land are required in connection with the preservation of pre-historic remains; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above four plots of land amounts to £810.0.0.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Furposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land.

The following land at Rabat - Gozo:-

- 1. A plot of land measuring 4 Sieghan and 3.2 Kejliet, bounded on the North and on the East by property of Mr. Anthony Vella, on the South by property of Mr. Michael Angelo Vella and on the West by Government property; it is the property of Mrs. Catherine Mizzi.
- 2. A plot of land measuring 1 Tomna and 4.8 Kejliet, bounded on the South by property of Mr. Michael Angelo Vella, on the East by Government property, on the West by property of Mrs. Catherine Mizzi and on the North by the remaining portion of the land of which such plot forms part; it is the property of Mr. Anthony Vella.
- 3. A plot of land measuring 3 Tmien and 7.9 Kejliet, bounded on the North in part by property of Mrs. Catherine Mizzi and in part by property of Mr. Anthony Vella, on the South by property of Mr. Anthony Vella, and on the East and on the west by Government property; it is the property of Mr. Michael Angelo Vella.
- 4. A plot of land measuring 1 Tomna, 3 Sieghan and 2.9 Kejliet, bounded on the North by property of Mr. Michael Angelo Vella, on the East in part by Government property and in part by property of Mr. Michael Angelo Vella, and on the West by Government property; it is the property of Mr. Anthony Vella.
