

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of nine plots of land at Xaghra, Gozo.

Since the said land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The plots of land in question are required by the Government for the purpose of road widening; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the said nine plots of land amounts to £86.4s.0d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Xaghra, Gozo:-

1. A plot of land of the area of 1 Siegh and 8.4 Kejllet, bounded on the North by property of Mr Carmel Attard, on the South and on the East by Ghajn Qamar Street, and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr Joseph Hili.

2. A plot of land of the area of 2.3 Kejllet, bounded on the North by property of Mr Joseph Attard, on the South by property of Mr Joseph Hili, on the East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr Carmel Attard.

3. A plot of land of the area of 1.1 Kejllet, bounded on the North by property of Mr Fortunato Attard, on the South by property of Mr Carmelo Attard, on the East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr Joseph Attard.

4. A plot of land of the area of 1.7 Kejllet, bounded on the North by property of Mrs Maria Giovanna Wood, on the South by property of Mr Joseph Attard, on the East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr Fortunato Attard.

5. A plot of land of the area of 1.2 Kejllet, bounded on the North by property of Mrs Ursola Konial, on the South by property of Mr Fortunato Attard, on the

East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mrs Maria Giovanna Wood.

6. A plot of land of the area of 1.3 Kejliet, bounded on the North by property of Mr Edward Grech and others, on the South by property of Mrs Maria Giovanna Wood, on the East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mrs Ursola Konial.

7. A plot of land of the area of 1.4 Kejliet, bounded on the North by property of Mr Joseph Theuma, on the South by property of Mrs Ursola Konial, on the East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr Edward Grech and others.

8. A plot of land of the area of 9 Kejliet, bounded on the North by property of Mr Salvatore Theuma, on the South by property of Mr Edward Grech and others, on the East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr Joseph Theuma.

9. A plot of land of the area of 6.7 Kejliet, bounded on the North by a public road, on the South by property of Mr Joseph Theuma, on the East by Ghajn Qamar Street and on the West by the remaining portion of the land of which this plot forms part; it is the property of Mr Salvatore Theuma.

The abovementioned land is shown on a plan marked L.D. 111/67, which may be seen on demand at the Land Office, 29, South Street, Valletta.
