

MEMORANDUM BY THE MINISTER OF JUSTICE  
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of eleven plots of land at Naxxar.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with the opening of Labour Road, Naxxar; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £4789.17.6.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Naxxar

1. A plot of land of the area of 3 Sieghan and 5.6 Kejliet, bounded on the North-East and North-West by property administered by Doctor Giuseppe Maria Camilleri LL.D., and on the South-East by a public road.
2. A plot of land of the area of 1.8 Kejliet, bounded on the South-West and North-West by property administered by Doctor Giuseppe Maria Camilleri LL.D., and on the South-East by a public road.
3. A plot of land of the area of 4.7 Kejliet, bounded on the North-East by property of Messrs. Borg and Aquilina, on the North-West by property of Mr. Bertu Camilleri, and on the South-East by a public road.
4. A plot of land of the area of 2 Tunoli and 1.6 Kejliet, bounded on the South-West by property of Mr. Bertu Camilleri, on the North-East by property of Mr. Salvatore Grima, on the North-West by property of Messrs. Borg and Aquilina, and on the South-East by a public road.
5. A plot of land of the area of 3 Tunoli, 1 Siegha and 1.8 Kejliet, bounded on the South-West by property of Messrs. Borg and Aquilina, on the North-West by property of Mr. Salvatore Grima, on the South-East partly by a public road and partly by property of Mr. Salvatore Grima, and on the North-East partly by property of Mr. Anthony Cassar and partly by property of the heirs of the late Joseph Scerri.
6. A plot of land of the area of 2 Sieghan and 5.1 Kejliet, bounded on the South-West by property of Mr. Salvatore Grima, on the North-West by property of Mr. Anthony Cassar, and on the South-East partly by property of the heirs of the late Joseph Scerri and partly by property of Mr. Salvatore Grima.
7. A plot of land of the area of 1 Siegha and 1.57 Kejliet, bounded on the North-West by property of Mr. Mordant Mills, on the South-East by property of Mrs. Annunziata Scerri, on the South by property of Mr. Anthony Cassar and on the North by Alley No.1, Mdina Road.

8. A plot of land of the area of 3 Sieghan and 3 Kejliet, bounded on the North-West by property of Mr. Anthony Cassar, on the South-West by property of Mr. Salvatore Grina and on the South-East by property of Mrs. Annunziata Scerri.
9. A plot of land of the area of 8.5 Kejliet bounded on the North by Mdina Road, on the South by property of Mrs. Annunziata Scerri, and on the South-East by property of Mr. Joseph Fenech.
10. A plot of land of the area of 1 Tonna and 7.5 Kejliet bounded on the North-West by Mdina Road, on the North by property of Mr. Joseph Fenech, and on the South and South-East by property of Mrs. Annunziata Scerri.
11. Part of premises No.13, Alley No.1, Mdina Road of an area of 17 square canes, consisting of part of an entrance hall, a room and part of a stairwell at ground floor level, part of a room overlying the said entrance hall, and the space overlying the said part of the stairwell at first floor level, bounded on the North by Alley No.1, Mdina Road, on the East by property of Mr. Anthony Cassar, and on the North-West by property of Mr. Mordant Mills.

The abovementioned land is shown on plan marked L.D. 1/69 which may, be seen on demand at the Land Office, 29, South Street, Valletta.
