

MEMORANDUM BY THE MINISTER OF JUSTICE  
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of sixteen plots of land at Birkirkara.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government for the formation of roads leading to Birkirkara housing scheme; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £1485. 0. 0d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Birkirkara:

1. A plot of land of the area of 1 Siegh and 0.4 Kejliet, including half the width of an alley, bounded on the North by property in course of acquisition by Government, on the South by property of Mr. Alfred Busuttil and others and on the East by an alley.
2. A plot of land of the area of 2 Sieghan, bounded on the North and East by property in course of acquisition by Government and on the West by property of the heirs of the late Carmelo Scembri.
3. A plot of land of the area of 1 Siegh and 1.4 Kejliet, bounded on the North and North-west by property in course of acquisition by Government, on the West by Government property and on the South and South-East by property of Mrs. Rosa Spiteri.
4. A plot of land of the area of 3 Sieghan and 6.2 Kejliet, bounded on the North and West by property in course of acquisition by Government and on the East by property of Mrs. Rosa Spiteri.
5. A plot of land of the area of 4.7 Kejliet, bounded on the North by property of Mr. Carmelo Borg, on the East by property in course of acquisition by Government, and on the West by property of Mr. Loreto Bonnici and others.
6. A plot of land of the area of 5.6 Kejliet including part of the rural structure thereon, bounded on the North-west by property of Mr. Gerald Azzopardi, on the East by property in course of acquisition by Government and on the West by property of Mr. Carmelo Borg.
7. A plot of land of the area of 5.6 Kejliet including part of a garage bounded on the North-west by property of Mr. Paul Gauci and others, on the East by property in course of acquisition by Government, on the South-East by property of Mr. Carmelo Borg and on the West by property of Mr. Gerald Azzopardi and others.

8. A plot of land of the area of 1 siegh and 1.64 kejllet, bounded on the North-East by property of 'Beneficji Vacanti', on the East by property in course of acquisition by Government, on the South-East by property of Mr. Gerald Azzopardi and others and on the West by property of Mr. Paul Gauci and others.

9. A plot of land of the area of 1 siegh and 0.3 kejllet, bounded on the South and East by property in course of acquisition by Government, on the South-West by property of Mr. Paul Gauci and others, and on the North by property of 'Beneficji Vacanti'.

10. A plot of land of the area of 3.9 kejllet, bounded on the East by Government property, on the South by property in course of acquisition by Government, on the North-West by property of Mr. Joseph Vella, and on the North by property of Doctor Antonio Galea LL.B.

11. A plot of land of the area of 1 siegh and 7.7 kejllet, including part of a rural structure thereon, bounded on the North-East by property of Mr. Joseph Vella, on the South-East by property of Doctor Antonio Galea, LL.B., on the North-West by a narrow road and on the South-West by property in course of acquisition by Government.

12. A plot of land of the area of 1 siegh and 2.7 kejllet, bounded on the North-East and South-East by property of Mr. Salvatore Sciberras, on the South-West partly by Government property and partly by property in course of acquisition by Government.

13. A plot of land of the area of 5.8 kejllet, including half the width of an alley, bounded on the North-East and North-West by an alley, on the South by property of Mr. Paul Gauci and others, and on the South-East by property of Mr. Gaetano Grech.

14. A plot of land of the area of 0.86 kejllet including half the width of an alley, bounded on the North by property of Mr. Gaetano Grech, on the North-West by an alley, on the South-West by property of Mr. Joseph Pirota, and on the South-East by property of Mr. Paul Gauci and others.

15. A plot of land of the area of 5.8 kejllet, including half the width of an alley, bounded on the North-East by property of Mr. Paul Gauci and others, on the North-West by an alley, on the South by property of Reverend Francis Micallef, and on the South-East by property of Mr. Joseph Pirota.

16. A plot of land of the area of 4.8 kejllet, including half the width of an alley, bounded on the

North by property of Mr. Joseph Firots, on the North-west by an alley, and on the South-East by property of Reverend Francis Micallef.
