

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of premises Nos. 27, 28 and 29, Rock Street, of parts of premises Nos. 15, 16 and 17, Valley Road, and of seven other plots of land at Jormi.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above land is required by the Government for the widening of Valley Road, Jormi; it is therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above land amounts to £6,102. 4. Od.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Formi:-

1. Premises No. 29, Rock Street.
2. Premises No. 28, Rock Street.
3. Premises No. 27, Rock Street.
4. A plot of land of the area of 1.24 Kejliet, bounded on the North by Rock Street, on the South-west by property of Doctor Albert Zammit Maempel M.D., and on the East by property of Mr. George Abela.
5. A plot of land of the area of 6 Kejliet, bounded on the North by Valley Street, on the South-west by property of Mr. George Abela, on the West by property of Doctor Albert Zammit Maempel M.D., and on the East by property of Reverend Vincent Xuereb.
6. A plot of land of the area of 6.5 Kejliet, bounded on the North-East by Valley Road, on the South-west by property of Reverend Vincent Xuereb and on the West by property of Mr. George Abela.
7. Part of premises No. 15, Valley Road, consisting of part of a garden of the area of 7.5 square canes, and a small room all at ground floor level, bounded on the South-East and South-West by Valley Street and on the North-East by property of Mr. Anthony Grima.
8. Part of garden of the area of 4.5 square canes, and part of a small room at ground floor level, bounded on the North-East by property of Mr. Martin Gatt, on the South-West by Valley Road, on the South-South-East by Alley No. 10 in Valley Road and on the West by Alley No. 9 in Valley Road.

9. Part of premises No. 16, Valley Road, consisting of part of a room at basement level, part of a room at ground floor level and part of a room at first floor level, each part having an area of 3 square canes, bounded on the North-west by Alley No. 10 in Valley Road, on the South-west by Valley Street, on the North-East by property of Mr. Martin Gatt and on the South-East by property of Mr. Saviour Sammut.

10. Part of premises No. 17, Valley Road, consisting of part of a shed of the area of 5.5 square canes at ground floor level, bounded on the South-west by Valley Road, on the South-East by Alley No. 11 in Valley Road, on the North-East by property of Mr. Saviour Sammut and on the North-west by property of Mr. Martin Gatt.

11. A plot of land of the area of 3.9 Kejliet, bounded on the North-East by property of Mr. Joseph Mercieca and on the South and South-west by Valley Road.

12. A plot of land of the area of 4 Sieghan and 4.9 Kejliet, bounded on the North-East by property of Mr. John Mercieca, on the South-East by property of Tagliaferro Estates and on the South-west by Valley Road.

13. A plot of land of the area of 4 Sieghan and 0.9 Kejliet, bounded on the North-East by property of Tagliaferro Estates, on the South-East by Old Mill Street and on the South-west by Valley Road.

The above mentioned land is shown on plan marked L.D. 269/70, which may be seen on demand at the Land Office, 25, South Street, Valletta.
