

MEMORANDUM BY THE MINISTER OF JUSTICE

LAND ACQUISITION (PUBLIC PURPOSES) ORDINANCE (CAP.136)

The attached draft Declaration by His Excellency the Governor-General refers to the release of five plots of land at Lija.

The five plots of land in question, together with two other plots, had been declared to be required for a public purpose by the competent authority by means of a Declaration signed by His Excellency the Governor-General on the 4th October, 1969, and published by Government Notice No 842 of the 14th October, 1969.

As the said five plots are no longer so required by the competent authority, the attached Declaration is intended for their release.

DECLARATION BY THE GOVERNOR-GENERAL

Whereas by declaration dated 4th October, 1969, published in the Government Gazette of the 14th October, 1969 under Notice No. 842, His Excellency the Acting Governor-General had declared amongst other items the under-mentioned land to be required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and whereas the undermentioned land is no longer so required, I hereby declare for all intents and purposes of law, that the undermentioned land is no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.

Description of the land

The following land at Lija:--

1. A plot of land of the area of 3.2 Kejliet, bounded on the west and east by property of the Noble Contino Alfred Sant Fournier and on the south by property of Mrs. Stella Fenech.
2. A plot of land of the area of 4 Sieghan and 3.2 Kejliet, bounded on the north by property of the Noble Contino Alfred Sant Fournier, on the east by property of Mrs. Stella Fenech and on the south and west by property of Mrs. Evelyn Cassar Torreggiani.
3. A plot of land of the area of 3 Sieghan and 2.4 Kejliet, bounded on the north by property of Mrs. Stella Fenech, on the east and south by property of Mrs. Evelyn Cassar Torreggiani and on the west by property of Mr. Andrew Fenech.
4. A plot of land of the area of 4 Tumoli and 8.4 Kejliet, bounded on the north partly by property of Francia Estates and partly by property of the Noble Contino Alfred Sant Fournier, on the east by property of Mrs. Stella Fenech and on the south by property of Mr. Andrew Fenech.
5. A plot of land of the area of 2 Tumoli, 2 Sieghan and 0.4 Kejliet, bounded on the north and east by property of Mrs. Evelyn Cassar Torreggiani, on the south by property of Mr. Andrew Fenech and on the west partly by High Street and partly by property of Mr. Andrew Fenech.

The abovementioned plots of land are shown as items Nos. 3, 4, 5, 6 and 7 in Government Notice No. 842/69 and as plots nos. 3, 4, 5, 6 and 7 on plan L.D. 273/68, which may be seen on demand at the Land Office, 29, South Street, Valletta.
