

MEMORANDUM BY THE MINISTER OF JUSTICE

AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of nine plots of land at Melliha.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with the widening of Marfa Road; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £1,511.18.0d.

This Declaration is to supersede that published by Government Notice No.448 dated 25th June, 1968.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Mellieha:

1. A plot of land of the area of 206.44 square canes, bounded on the North-West and North-East by Marfa Road, and on the South and South-East by property of Dr. Alexander Depiro LL.D.
2. A plot of land of the area of 21.38 square canes, bounded on the North-West and North-East by Marfa Road, and on the South-West and South-East by property of Mr. John Vella.
3. A plot of land of the area of 24.33 square canes, bounded on the North-East by Marfa Road, on the West-North-West by property of Mr. Carmelo Muscat and on the South by property of Mr. Joseph Borg.
4. A plot of land of the area of 41.66 square canes, bounded on the North-East by Marfa Road, on the East-South-East by property of Mr. Joseph Borg and on the South-West by property of Mr. Carmelo Muscat.
5. A plot of land of the area of 39.35 square canes, bounded on the North and North-East by Marfa Road, and on the East-South-East by property of Mr. Carmelo Muscat.
6. A plot of land of the area of 101.86 square canes, bounded on the North-East by property of Mr. Carmelo Vella and others and on the North-West and South by Marfa Road.
7. A plot of land of the area of 38.34 square canes, bounded on the North-East by property of Mr. Carmelo Vella, on the East-South-East by property of Mr. Joseph Borg and on the South-West by Marfa Road.
8. A plot of land of the area of 94.37 square canes, bounded on the North-West and North-East by property of Mr. Joseph Borg, on the East by property of Mr. Carmelo Vella and on the South by Marfa Road.

9. A plot of land of the area of 30.6 square canes, bounded on the north-west and North-East by property of Mr. Carmelo Vella, on the south-south-west by property of Mr. Joseph Borg and on the south-east by Marfa Road.

The abovementioned land is shown on plan marked L.D. 256/70, which may be seen on demand at the Land Office, 29, South Street, Valletta.

This declaration is to supersede that published by Government Notice No. 448 dated 25th June, 1968.
