

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor General refers to the compulsory acquisition of nineteen plots of land at Naxxar.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government for a Housing Scheme; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £9,840..17..11d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Naxxar:

1. A plot of land of the area of 1 Siegh and 5.14 Kejliet, bounded on the North by 21st September Avenue, on the West by a public lane and on the South partly by property of Mr. Joseph Cassar and partly by property of Mr. Giuseppe Deguara.
2. A plot of land of the area of 1 Siegh and 9.4 Kejliet, bounded on the North by property of Mr. Giuseppe Deguara, on the West by a public lane, on the East by property of Mr. Joseph Cassar and on the South by property of Mr. Francis Galea.
3. A plot of land of the area of 1 Tonna and 5 Sieghan, bounded on the North by property of Mr. Joseph Cassar, on the West by a public lane and on the South by property of Mr. Joseph Falzon.
4. A plot of land of the area of 2 Tunoli, 4 Sieghan and 3.9 Kejliet, bounded on the North by property of Mr. Francis Galea, on the West partly by a public lane and partly by property of Mr. Joseph Falzon and on the South partly by property of the heirs of the late Carmelo Camilleri and partly by property of Saura Hospital.
5. A plot of land of the area of 1 Tonna, 2 Sieghan and 3 Kejliet, bounded on the North by property of Mr. Joseph Falzon, on the South and on the West by property of the heirs of the late Carmelo Camilleri and on the East by property of Saura Hospital.
6. A plot of land of the area of 1 Tonna, 4 Sieghan and 5.8 Kejliet, bounded on the North-East by property of Mr. Nazzareno Micallef, on the South by property of Saura Hospital and on the West by property of Mr. Joseph Falzon.
7. A plot of land of the area of 9 Tunoli, 2 Sieghan and 1.1 Kejliet, bounded on the North by property of Nazzareno Micallef, on the West by property of the heirs of the late Carmelo Camilleri, on the East by property of the Archbishop's Estates and on the South by property of Mrs. Annunziata Chetcuti.
8. A plot of land of the area of 4.33 Kejliet, bounded on the North by property of Mrs. Annunziata Chetcuti, on the South by property of Mr. Francis Sammut and on the West by property of the heirs of the late Carmelo Camilleri.

9. A plot of land of the area of 3 Tunoli, 5 Sieghan and 7.2 Kejliet, bounded on the North by property of the Archbishop's Estates, on the South by property of Mr. Francis Sammut and on the North-East by property of Mr. Francesco Gauci Sant.

10. A plot of land of the area of 2 Tunoli, 4 Sieghan and 1.8 Kejliet, bounded on the North by property of Mrs. Annunziata Chetcuti, on the South by property of Mrs. Gina Scerri, on the South-East by a public lane and on the West by property of Mr. Francis Sammut.

11. A plot of land of the area of 2 Tunoli, 1 Siegh and 8 Kejliet, bounded on the North by property of Mr. Francis Sammut, on the South by property of Mrs. Ersilia Cortis and on the South-East by a public lane.

12. A plot of land of the area of 8.6 Kejliet, bounded on the North, North-West and North-East by property of Mrs. Gina Scerri and on the South by property of Mrs. Ersilia Cortis.

13. A plot of land of the area of 2 Sieghan and 8.1 Kejliet, bounded on the North by property of Mr. Carmelo Zammit, on the South by property of the Archbishop's Estates and on the West by property of Mr. Nezzareno Micallef.

14. A plot of land of the area of 7 Tunoli, 3 Sieghan and 9.6 Kejliet, bounded on the North by property of Mr. Carmelo Zammit, on the West by property of Saura Hospital, on the East by property of the Noble John dei Conti Sant Manduca and on the South-East by property of Mr. Francesco Gauci Sant.

15. A plot of land of the area of 3 Tunoli, 2 Sieghan and 0.6 Kejliet, bounded on the North-West by property of the Archbishop's Estates, on the South-East by a lane and on the South-West by property of Mrs. Annunziata Chetcuti.

16. A plot of land of the area of 5 Sieghan and 1.6 Kejliet, bounded on the North by property of the Noble John dei Conti Sant Manduca, on the West and South by property of the Archbishop's Estates and on the East by property of Messrs. Vica Limited.

17. A plot of land of the area of 5 Sieghan and 6.1 Kejliet, bounded on the North by property of Messrs. Vica Limited, on the West by property of the Noble John dei Conti Sant Manduca, on the South-East by a lane and on the East by property of the Noble John dei Conti Sant Manduca.

18. A plot of land of the area of 2 Sieghan and 1.5 Kejliet bounded on the North by property of the Noble John dei Conti Sant Manduca, on the South by a lane, on the West by property of Messrs. Vica Limited and on the East by property of Mrs. Catherine Sciberros.

19. A plot of land of the area of 2 Sieghan and 8.1 Kejliet, bounded on the South by a lane, on the North by property of Mrs. Catherine Sciberros and on the West by property of the Noble John dei Conti Sant Manduca.
