

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of twelve (12) plots of land at Sahrija, limits of Rabat, Malta.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government for the opening of a new road leading to Fomm-ir-Rih Bay, limits of Rabat; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £M 496. 17. 6.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned Land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Bahrija, limits of Rabat - Malta.

1. A plot of land measuring 4.2 Kejliet (79.0 square metres), bounded on the south and west by a public road and on the East by property of Mrs. Elisa Aquilina and others.
2. A plot of land measuring 2.9 Kejliet (54.9 square metres), bounded on the North and East by a public land and on the South-west by property of Mrs. Elisa Aquilina and others.
3. A plot of land measuring 2 Tmien, 4 Sieghan and 5.5 Kejliet (3103.3 square metres), bounded on the North-East, South-west and South by property of Mrs. Elisa Aquilina and others.
4. A plot of land measuring 2.1 Kejliet (38.6 square metres), bounded on the North-East and South-East by property of Mrs. Elisa Aquilina and others and on the South-West by a Public Lane.
5. A plot of land measuring 0.69 Kejliet (12.9 square metres), bounded on the East and North by a public lane and on the South-West by property of Mrs. Elisa Aquilina and others.
6. A plot of land measuring 1 Siegh (187.1 square metres), bounded on the East by property of Mrs. Elisa Aquilina and others, on the South by a Public Lane and on the West partly by a Public Lane and partly by property of Mrs. Elisa Aquilina and others.
7. A plot of land measuring 2.4 Kejliet (45.22 square metres), bounded on the East and South-East by a Public Lane and on the West by property of Mrs. Elisa Aquilina and others.
8. A plot of land measuring 6.2 Kejliet (116.4 square metres), bounded on the South-West and West by a public lane and on the East by property of Mrs. Elisa Aquilina and others.
9. A plot of land measuring 1.8 Kejliet (33.8 square metres), bounded on the North and East by a public lane and on the West by property of Mrs. Elisa Aquilina and others.

10. A plot of land measuring 0.088 Kejliet (1.7 square metres), bounded on the North-west and south-west by a Public Lane and on the East by property of Mrs. Elisa Aquilina and others.

11. A plot of land measuring 5 Sieghan, 3.67 Kejliet (1007.98 square metres), bounded on all sides by property of Mrs. Elisa Aquilina and others.

12. A plot of land measuring 1 Tomna, 4 Sieghan, 7.2 Kejliet (2011 square metres), bounded on all sides by property of Mrs. Elisa Aquilina and others.
