

MEMORANDUM BY THE MINISTER OF JUSTICE

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of 39 tenements at Valletta.

These tenements are to be acquired by the Government under possession and use terms.

The above tenements are required by the Government in connection with the slum clearance programme; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

Honourable Ministers are invited to recommend.
