

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of four plots of land at Kirkop and Gudja.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government for the extension of Luqa Runway; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned Land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

DESCRIPTION OF THE LAND

The following land in the limits of Kirkop and Gudja:--

1. A plot of land measuring approximately 4 Tumoli (4497 square metres) situated in the area known as TAD-DAWI, in the limits of Kirkop. It is bounded on the North, East and South by public roads and on the South-West by property of the Archiepiscopal Curia.

2. A plot of land measuring approximately 42 Tumoli (47217 square metres) situated in the area known as TA SAN NIKOLA, in the limits of Kirkop. It is bounded on the North, East and South-East by Government property and on the West partly by Government property and partly by property of the Archiepiscopal Curia.

3. A plot of land measuring approximately 371 Tumoli (417083 square metres) situated in the area known as TA CINCRA, TA SAN NIKOLA, TAL KAPPELLA, TAL BAJDA, TA HARRUB RUMMIEN, TAŻ-ŻEBBUĠIJA, TAŻ-TAJJAR, in the limits of Kirkop and Gudja. It is bounded on the North-East by property of the Archiepiscopal Curia and others, on the North-West and South-West partly by property of the Archiepiscopal Curia and partly by Government property and on the South by a public road.

4. A plot of land measuring approximately 4 Tumoli (4497 square metres) situated in the area known as TA BIR MIFTUH, in the limits of Gudja. It is bounded on the North East by a public road, on the South-West by property of the Archiepiscopal Curia, on the North-West and South-East by property of the Archiepiscopal Curia and others.

The abovementioned land is shown on plan marked L.D. 124/72, which may be seen on demand at the Land Office, 29 South Street, Valletta.
