

Land. 845/67No. 923MEMORANDUM BY THE MINISTER OF JUSTICE AND PARLIAMENTARY AFFAIRSLand Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of 14 plots of land at Zurrieq.

Since the land in question is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above land is required by the Government in connection with the construction of the panoramic road; it is therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above 14 plots of land amounts to £260. 2s. 8d.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the land

The following land at Zurrieq.

1. A plot of land of the area of 2 sieghan and 7.2 kejljet, bounded on the South-East by a public road, on the North-West by the remaining portion of the land of which such plot forms part, and on the North-East by property of same owners; it is the property of Mr denato Bonnici and others.
2. A plot of land of the area of 1 siegh, bounded on the South-East by a public road, on the North-West by the remaining portion of the land of which such plot forms part, and on the South-West by property of same owners; it is the property of Mr denato Bonnici and others.
3. A plot of land of the area of 3 sieghan and 5 kejljet, bounded on the South-West by a public road, on the East by property of Mr Joseph Camilleri and others, and on the North-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Arthur E. Cutugno A.& C.E.
4. A plot of land of the area of 2 sieghan and 4.4. kejljet, bounded on the West by property of Mr Arthur E. Cutugno A.& C.E., on the North partly by the remaining portion of the land of which such plot forms part and partly by a public road, and on the South by the remaining of the land of which such plot forms part; it is the property of Mr Joseph Camilleri and others.
5. A plot of land of the area of 9.4 kejljet, bounded on the West and South by a public road, and on the North and East by the remaining portion of the land of which such plot forms part; it is the property of Miss Maria Anna Axiaq and others.
6. A plot of land of the area of 7.3 kejljet, bounded on the North-East by a public road, on the South-East by property of Mr Lorenzo Cassar and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of Miss Maddalena Cachia.
7. A plot of land of the area of 1 siegh and 5.7 kejljet, bounded on the North-East by a public road, on the North-West by property of Miss Maddalena Cachia, and on the South-West by the remaining portion of the land of which such plot forms part; it is the property of Mr Lorenzo Cassar.
8. A plot of land of the area of 2 sieghan and 3.4 kejljet, bounded on the South-West and South-East by a public road and on the North-West and North-East by the remaining portion of the land of which such plot forms part; it is the property of Mr Austin Attard Montalto A.& C.E.

9. A plot of land of the area of 1 siegh and 1.7 kejllet, bounded on the North-West, and North-East by a public road, and on the South-West and South-East by the remaining portion of the land of which such plot forms part; it is the property of Mr Arthur E. Cutugno A.& C.E.

10. A plot of land of the area of 3.5 kejllet, bounded on the North-West and North-East by the remaining portion of the land of which such plot forms part; and on the South-West and South-East by a public road; it is the property of Mr Michael Grixti.

11. A plot of land of the area of 1.2 kejllet, bounded on the West by property of the Parish Church of Zurrieq, on the South by a public road, and on the North by the remaining portion of the land of which such plot forms part; it is the property of the Mensa Capitularis of the Parish Church of Cospicua.

12. A plot of land of the area of 0.4 kejllet, bounded on the North by a public road, on the East by property of the Parish Church of Zurrieq, and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Mensa Capitularis of the Parish Church of Cospicua.

13. A plot of land of the area of 0.7 kejllet, bounded on the North by a public road, on the West by property of the Mensa Capitularis of the Parish Church of Cospicua and on the South by the remaining portion of the land of which such plot forms part; it is the property of the Parish Church of Zurrieq.

14. A plot of land of the area of 1.5 kejllet, bounded on the West by property of the Mensa Capitularis of the Parish Church of Cospicua, on the South by a public road, and on the North by the remaining portion of the land of which such plot forms part; it is the property of the Parish Church of Zurrieq.

The abovementioned land is shown on a plan marked L.D. 206/67, which may be seen on demand at the Land Office, 29, South Street, Valletta.
