

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap. 136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of twenty-two plots of land at Siggiewi and Zebbug, Malta.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with the widening and re-aligning of the Siggiewi Approach Road; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the freehold value of the above plots of land (with the exception of plots 8 and 9 which could not be inspected) amounts to £3,918. 3. 0.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Siggiewi and Zebbug, Malta:-

1. A plot of land at Zebbug of the area of 2 Sieghan, 7.65 Kejliet, bounded on the North by the property of Mr. Joseph Sant Cassia, on the South-West and East by a public road;
2. A plot of land at Zebbug of the area of 2 Sieghan, 9.9 Kejliet, bounded on the North by the property of Mr. Anthony Vella, on the South-West and South-East by a public road;
3. A plot of land at Zebbug of the area of 4.66 Kejliet, bounded on the North by the property of Mr. Carmelo Fenech, on the East by the property of Mr. Anthony Vella and on the South by a public road;
4. A plot of land at Zebbug of the area of 5 Sieghan, 9.18 Kejliet, including the rural structures thereon, bounded on the North-West and North-East by a public road and on the South by the property of Mr. John Mary Chircop;
5. A plot of land at Zebbug of the area of 2 Sieghan, 7.9 Kejliet, bounded on the North-West and South-West by a public road, and on the South-East by the property of Mr. George Curmi;
6. A plot of land at Zebbug of the area of 2 Sieghan, 1.5 Kejliet, bounded on the North-West by a public road, on the South-West by the property Mr. Salvatore Pace and on the South-East by the property of Mr. Emmanuel Attard;

7. A plot of land at Zebbug of the area of 3 Sieghan, 8.45 Kejliet, bounded on the South-West by a public road, on the North-West by Government property and on the South-East by the property of Mr. Salvatore Pace;
8. A plot of land at Zebbug of the area of 4 Sieghan, 1.8 Kejliet, bounded on the West, South and East by public roads;
9. A plot of land at Zebbug of the area of 1 Tomna, 0 Sieghan, 5.23 Kejliet, bounded on the North and West by a public road and on the East by the property of Dr. Alexander Apap Bologna;
10. A plot of land at Zebbug of the area of 1 Siegh, 4.95 Kejliet, bounded on the West by the property of Major D.C. Formosa Gauci, on the South and East by a public road;
11. A plot of land at Zebbug of the area of 8.29 Kejliet, bounded on the South and East by a public road and on the North by Qirda Valley;
12. A plot of land at Zebbug of the area of 2 Tmien, 2 Sieghan, 0.74 Kejliet, bounded on the South by an alley, on the East by the property of Mr. Dominic Cilia and on the West by a public road;
13. A plot of land at Zebbug of the area of 1 Tomna, 4 Sieghan, 9.73 Kejliet, bounded on the North by an Alley, on the West by a public road and on the South-East by the property of Mr. Francis Cremona;
14. A plot of land at Zebbug of the area of 1 Tomna, 3 Sieghan, 0.89 Kejliet, including a rural structure thereon, bounded on the West by a public road, on the North-East by the property of Mr. Francis Cremona and on the South-East by the property of Mr. Philip Mallia;
15. A plot of land at Zebbug of the area of 8.2 Kejliet, bounded on the North and West by the property of Mr. Philip Mallia and on the East by property of the Franciscan Fathers of Rabat, Malta;
16. A plot of land at Zebbug of the area of 1.38 Kejliet, bounded on the South by the property of Messrs. Agius Brothers, on the West by the property of Rev. Fr. Angelo Fenech and on the East by a public road;
17. A plot of land at Zebbug of the area of 1 Siegh, 5.46 Kejliet, bounded on the North by the property of Rev. Fr. Angelo Fenech, on the East by a public road and on the West by the property of Messrs. Agius Brothers;
18. A plot of land at Siggiewi of the area of 1 Siegh, 3.04 Kejliet, including a rural structure thereon, bounded on the North by a public passage, on the South by property of the Archbishop's Curia and on the East by a public road;

19. A plot of land at Siggiewi of the area of 2.16 Kejliet including rural structures thereon, bounded on the North by the property of Miss Carmela Cilia, on the East by a public road, and on the West by property of the Archbishop's Curia;

20. A plot of land at Zebbug of the area of 1 Siegh, 2.7 Kejliet, including rural structures thereon, bounded on the South and West by a public road and the East by property of the Archbishop's Curia;

21. A plot of land at Siggiewi of the area of 1.30 Kejliet bounded on the South by the property of Dr. Raphael Patignott, M.D., on the East by a public road and the West by property of the Archbishop's Curia;

22. A plot of land at Siggiewi of the area of 1 Siegh, 8.48 Kejliet, bounded on the North by Church property, on the East by a public road and on the West by the property of Dr. Raphael Patignott, M.D.

The abovementioned land is shown on plan marked L.D. 250/71, which may be seen on demand at the Land Office, 29, South Street, Valletta.
