

MEMORANDUM BY HIS MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the compulsory acquisition of sixteen (16) plots of land at Farxien, Lejtun, Ghaxaq and Fgura.

Since this land is permanently required by the Government, it is proposed to acquire it by absolute purchase.

The above plots of land are required by the Government in connection with the projected widening of the road leading from Farxien By-pass to Sulebel Industrial Estate; they are therefore required for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136).

From the report by the Land Engineer it transpires that the total freehold value of the above plots of land amounts to £451. 0. 0.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

I hereby declare that the undermentioned land is required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and that the acquisition thereof is to be by absolute purchase.

Description of the Land

The following land at Tarxien, Sektun, Ghaxaq and Mgura:-

1. A plot of land at Ghaxaq of the area of 0.74 Kejla, bounded on the North-west and South-west by a public road, and on the South-east by property of Tarxien Parish Church.
2. A plot of land at Tarxien of the area of 1 siegh 0.7 Kejla, bounded on the South and South-east by a public road, on the North by property of the Franciscan Fathers of Rabat and on the North-west by property of Dr. John Caruana Galizia M.D.
3. A plot of land at Ghaxaq of the area of 4.2 Kejliet, bounded on the North and North-west by a public road, and on the South-east by property of Tarxien Parish Church.
4. A plot of land at Tarxien of the area of 3 sieghan 4.1 Kejliet, bounded on the North-west by property of the Franciscan Fathers of Rabat, on the South, South-east and East by a public road.
5. A plot of land at Ghaxaq of the area of 7.9 Kejliet, bounded on the North, North-west and North-east by a public road and on the South by property of Tarxien Parish Church.
6. A plot of land at Sektun of the area of 4.3 Kejliet, bounded on the North, West and South by a public road and on the East by property of St. Ursula Convent of Valletta.
7. A plot of land at Tarxien of the area of 4.5 Kejliet, bounded on the South by a public road, on the North-west by property of the Franciscan Fathers of Rabat and on the East by property of Mr. Michael Scicluna.
8. A plot of land at Tarxien of the area of 2 sieghan, 5.9 Kejliet, bounded on the South-east by a public road, on the North-west by property of Mr. Michael

Scicluna, on the North by property of Mr. Francis Farrugia and on the West by property of the Franciscan Fathers of Rabat.

9. A plot of land at Tarxien of the area of 6.9 hejliet, bounded on the North-west by property of Mr. Francis Farrugia, on the South-east by a public road, on the South-west by property of Mr. Michael Scicluna and on the North-east by property of Dr. V. Camilleri Preziosi, M.B.

10. A plot of land at Tarxien of the area of 6.9 hejliet, bounded on the North-west by property of Dr. V. Camilleri Preziosi M.B., on the South-east by a public road, on the South-west by property of Mr. Francis Farrugia and on the North-east by property of Mr. John Abdilla and others.

11. A plot of land at Tarxien of the area of 2 hejliet, bounded on the North-west by property of Mr. John Abdilla, on the South-east by a public road, on the South-west by property of Dr. V. Camilleri Preziosi M.B., and on the North-east by property of the Archbishop's Curia.

12. A plot of land at Tarxien of the area of 5.1 hejliet, bounded on the North-west by property of the Archbishop's Curia, on the South-east by a public road, on the South-west by property of Mr. John Abdilla and on the North-east by property of Mr. Maurice Pisani.

13. A plot of land at Tarxien of the area of 2 Sieghan, 5.9 hejliet, bounded on the North-west by property of Mr. Maurice Pisani, on the South-east by a public road and on the South-west by property of the Archbishop's Curia.

14. A plot of land at Sejtun of the area of 4.3 hejliet, bounded on the West by a public road, on the East by property of Miss Bernarda Grixti and on the North by Government property.

15. A plot of land at Fgura of the area of 2 hejliet, bounded on the West and South by a public road and on the North-east by property of the Reverend Carmelo Sant.

16. A plot of land at Fgura of the area of 2 Sieghan 0.3 hejliet, bounded on the North-west by property of the Carmelite Fathers of St. Julian's, on the South and South-east by a public road.

The abovementioned land is shown on plan marked L.D. 241/71, which may be seen on demand at the Land Office, 29, South Street, Valletta.
