

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the release of thirteen (13) plots of land in the limits of Birzebbuga.

The thirteen (13) plots of land in question had been declared to be required for a public purpose by the competent authority by means of a Declaration signed by His Excellency the Governor-General on the 25th February, 1969, and published by Government Notice No. 203 of the 25th February, 1969.

As the thirteen (13) plots of land are no longer so required by the competent authority, the attached Declaration is intended for their release.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

Whereas by declaration dated 25th February, 1969, published in the Government Gazette of the 25th February, 1969 under Notice No. 203, His Excellency the Governor-General had declared the undermentioned land to be required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and whereas the undermentioned land is no longer so required, I hereby declare for all intents and purposes of law, that the undermentioned land is no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.

Description of the land

The following land in the limits of Birzebbugia:-

1. A plot of land of the area of 2 Tmien, 4 Sieghan and 8 Kejliet, including the rural structures thereon and a farmhouse, bounded on the West by a public road, on the South-East by property of Mr. Francis Polidano and on the South by property of the Parish Church of Qrendi; it is the property of the Parish Church of Qrendi.
2. A plot of land of the area of 3 Tmien and 3 Sieghan, bounded on the West by a public road, on the North by property of the Parish Church of Qrendi and on the South-West by property of Mr. Joseph Aquilina; it is the property of the Parish Church of Qrendi.
3. A plot of land of the area of 1 Tonna, 4 Sieghan and 5 Kejliet, including the rural structure thereon and a farmhouse, bounded on the North-East by a public road, on the South-East by property of Mrs. Giuseppina Azzopardi and on the South-West by property of Miss Angela Polidano; it is the property of Mr. Francis Polidano.
4. A plot of land of the area of 2 Tmien, 1 Siegh and 5 Kejliet, bounded on the North by property of the Parish Church of Qrendi, on the West by property of Mr. Giuseppe Aquilina and on the South partly by property of Mr. John Farrugia and partly by property of the Parish Church of Floriana; it is the property of Miss Angela Polidano.
5. A plot of land of the area of 10 Tmien and 4

Sieghan, including the rural structures thereon, bounded on the North partly by property of Mrs. Giuseppina Azzopardi and partly by property of Miss Angela Polidano, on the West by property of the Parish Church of Floriana and on the East partly by property of Mr. Emmanuel Baldacchino and partly by a lane; it is the property of Mr. John Farrugia.

6. A plot of land of the area of 2 Tmien, 1 Siegh and 5 Kejliet, bounded on the West by property of the Parish Church of Floriana, on the East and on the South by property of Mr. John Farrugia; it is the property of the Parish Church of Floriana.

7. A plot of land of the area of 3 Tmien, 4 Sieghan and 5 Kejliet, including the rural structure thereon, bounded on the North-East by a public road, on the South-West by property of Mr. John Farrugia and on the South-East by a lane; it is the property of Mr. Emanuel Baldacchino.

8. A plot of land of the area of 3 Tmien, 2 Sieghan and 4 Kejliet, bounded on the North-East by a public road, on the South-East by property of Mr. Emmanuel Baldacchino and on the North-West by property of Mr. Francis Polidano; it is the property of Mrs. Giuseppina Azzopardi.

9. A plot of land of the area of 1 Tomna, 3 Sieghan and 7.5 Kejliet, including the rural structures thereon and a farmhouse, bounded on the North-West by a public road, on the North-East by property of the Parish Church of Floriana and on the South-West by property of the heirs of the late Dr. Albert Glenday, M.D.; it is the property of Mr. Joseph Aquilina.

10. A plot of land of the area of 1 Tomna, bounded on the North by property of Mr. Joseph Aquilina, on the West by property of the heirs of the late Dr. Albert Glenday, M.D. and on the South by a lane; it is the property of Mr. Joseph Aquilina.

11. A plot of land of the area of 1 Tomna and 3 Kejliet, including the rural structure thereon, bounded on the East by property of Mr. John Farrugia, on the West by a public road and on the South by a public passageway; it is the property of the Parish Church of Floriana.

12. A plot of land of the area of 1 Tomna, 4 Sieghan and 5 Kejliet, including the rural structure thereon, bounded on the North by a lane, on the East partly by property of the

Parish Church of Floriana and partly by property of Mr. John Farrugia and on the West by a public road; it is the property of the Parish Church of Floriana.

13. A plot of land of the area of 4 Sieghan, including the rural structures thereon, bounded on the North-East partly by property of Mr. Joseph Aquilina and partly by property of Mr. Giuseppe Aquilina, on the South-East by a lane and on the West by a public road; it is the property of the heirs of the late Dr. Albert Glenday, M.D.

The abovementioned land is shown on a plan marked L.D. 66/69 which may be seen on demand at the Land Office, 29, South Street, Valletta.
