

MEMORANDUM BY THE MINISTER OF JUSTICE
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the release of fourteen (14) plots of land in the limits of Birzebbuga.

The fourteen (14) plots of land in question had been declared to be required for a public purpose by the competent authority by means of a Declaration signed by His Excellency the Governor-General on the 24th February, 1969, and published by Government Notice No. 202 of the 25th February, 1969.

As the said fourteen (14) plots of land are no longer so required by the competent authority, the attached Declaration is intended for their release.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

Whereas by declaration dated 24th February, 1969 published in the Government Gazette of the 25th February, 1969 under Notice No. 202, His Excellency the Governor-General had declared the undermentioned land to be required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and whereas the undermentioned land is no longer so required, I hereby declare for all intents and purposes of law, that the undermentioned land is no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.

Description of the land

The following land, limits of Birzebbugia:-

1. A plot of land of the area of 3 Tmien, 2 Sieghan and 7 Kejliet, bounded on the North by a public road, on the East by property of Mr. William Bondin and on the West by a lane; it is the property of Mr. Joseph Vella Bonavita.
2. A plot of land of the area of 3 Tmien, 4 Sieghan and 2 Kejliet, bounded on the North and on the East by public roads and on the West by property of Mr. Joseph Vella Bonavita; it is the property of Mr. William Bondin.
3. A plot of land of the area of 3/4 Tmien and 4 Sieghan, including a farmhouse, bounded on the North partly by property of Mr. Joseph Vella Bonavita and partly by property of Mr. William Bondin, on the West partly by property of Mr. Melitone Caruana, partly by property of the Government of Malta and partly by property of the Legacy "Roselli Massa" administered by Mr. Victor Darmanin, and on the South by a lane; it is the property of the Parish Church of Zurrieq.
4. A plot of land of the area of 3 Tmien, 3 Sieghan and 6 Kejliet, bounded on the North by property of Mr. Joseph Vella Bonavita, on the West by a lane and on the South by property of the Government of Malta; it is the property of unknown and uncertain owners.
5. A plot of land of the area of 1 Tomna, 1 Siegh and 7.5 Kejliet, including a passageway, bounded on the North partly by property of Mr. Joseph Vella Bonavita and partly by property of unknown and uncertain owners, on the East by

property of the Parish Church of Zurrieg and on the South by property of the Government of Malta; it is the property of Mr. Melitone Caruana.

6. A plot of land of the area of 5 Tmien, including the rural structure thereon, bounded on the North and on the East by property of the Parish Church of Zurrieg and on the South by a lane; it is the property of the Legacy "Roselli Massa" administered by Mr. Victor Darmanin.

7. A plot of land of the area of 16 Tmien, including the structures thereon, bounded on the North by a public road, on the South by the foreshore and on the West partly by property of the Government of Malta and partly by the foreshore; it is the property of the heirs of the late Carlo Camilleri.

8. A plot of land of the area of 3 Tmien, 1 Siegh and 5 Kejllet, bounded on the North by a public road, on the East by property of the Government of Malta and on the West by property of the heirs of the late Michael Cachia and others; it is the property of the heirs of the late Michael Cachia.

9. A plot of land of the area of 4 Tmien and 4 Sieghan, bounded on the North by a public road, on the East by property of the heirs of the late Michael Cachia and on the South by property of the Government of Malta; it is the property of the heirs of the late Michael Cachia as regards the Directum Dominium and of Mr. Michael Attard and Mr. John Grima as regards the Utile Dominium.

10. A plot of land of the area of 12 Tmien, 3 Sieghan and 3 Kejllet, bounded on the North and on the West by a public passageway, on the East by property of the Government of Malta and on the South by the foreshore; it is the property of the Government of Malta as regards the Directum Dominium and of Mr. John Xuereb as regards the Utile Dominium.

11. A plot of land of the area of 3 Tmien and 3 Sieghan, including the rural structure thereon, bounded on the North by a public road and on the West and South by a public passageway; it is the property of unknown and uncertain owners.

12. A plot of land of the area of 7 Tmien, 0 Sieghan and 8 Kejllet, bounded on the North, South, East and West by a public passageway; it is the property of the Government of Malta as regards the Directum Dominium and of Mr. John Xuereb as regards the Utile Dominium.

13. A plot of land of the area of 11 Tmien and 1 Siegh, bounded on the North and on the West by property of the Government of Malta and on the South by a public passageway; it is the property of unknown and uncertain owners.

14. A plot of land of the area of 4 Tmien, 1 Siegh and 9 Kejliet, bounded on the North, South, East and West by a public passageway; it is the property of the Government of Malta as regards the Directum Dominium and of Mr. John Xuereb as regards the Utile Dominium.

The above mentioned land is shown on a plan marked L.D. 65/69 which may be seen on demand at the Land Office, 29, South Street, Valletta.
