

MEMORANDUM BY THE MINISTER OF JUSTICE  
AND PARLIAMENTARY AFFAIRS

Land Acquisition (Public Purposes) Ordinance (Cap.136)

The attached Declaration by His Excellency the Governor-General refers to the release of twelve (12) plots of land in the limits of Birzebbugia.

The twelve (12) plots of land in question had been declared to be required for a public purpose by the competent authority by means of a Declaration signed by His Excellency the Governor-General on the 19th February, 1969, and published by Government Notice No. 182 of the 20th February, 1969.

As the said twelve (12) plots of land are no longer so required by the competent authority, the attached Declaration is intended for their release.

Honourable Ministers are invited to recommend.

DECLARATION BY THE GOVERNOR-GENERAL

Whereas by declaration dated 19th February, 1969 published in the Government Gazette of the 20th February, 1969 under Notice No. 182, His Excellency the Governor-General had declared the undermentioned land to be required by the competent authority for a public purpose in accordance with the provisions of the Land Acquisition (Public Purposes) Ordinance (Chapter 136) and whereas the undermentioned land is no longer so required, I hereby declare for all intents and purposes of law, that the undermentioned land is no longer required by the competent authority for a public purpose in accordance with the provisions of the aforementioned Ordinance.

Description of the Land  
-----

The following land in the limits of Birzebbugia:-

1. A plot of land of the area of 2 Tumoli, 3 Sieghan and 3 Kejliet, bounded on the North by a public road, on the West by property of the heirs of the late Gaetano Polidano and on the South by property of the Noble George Cassar Desain; it is the property of Mr. John Grixti.
2. A plot of land of the area of 6 Tumoli, bounded on the North by property of Mr. John Grixti, on the West by property of Mr. Clive Simpson, and on the South by Government property; it is the property of the Noble George Cassar Desain.
3. A plot of land of the area of 3 Sieghan, bounded on the North by a public road, on the East by property of Mr. John Grixti, and on the South by property of Mr. Clive Simpson; it is the property of the heirs of the late Gaetano Polidano.
4. A plot of land of the area of 3 Tumoli and 5 Sieghan, bounded on the North by property of the heirs of the late Gaetano Polidano, on the West by property administered by Reverend Canon Paul Borg as Economo "Beneficciji Vacanti", and on the East by property of the Noble George Cassar Desain; it is the property of Mr. Clive Simpson.
5. A plot of land of the area of 2 Tumoli and 3 Sieghan bounded on the North and West by property of Mr. Clive Simpson, and on the East and South by Government property; it is the property of the heirs of the late Gaetano Polidano.

6. A plot of land of the area of 1 Tumolo and 5 Kejliet, including a farmhouse, bounded on the North by property of Mr. Vincent Cachia as regards the Utile Dominium, and of property administered by Reverend Canon Paul Borg as Economo Beneficceji Vacanti as regards the Directum Dominium, on the East by property of Mr. Clive Simpson, and on the South by a road; it is administered by Reverend Canon Paul Borg as Economo Beneficceji Vacanti.
7. A plot of land of the area of 5 Tumoli and 2 Sieghan, bounded on the North by a public road, on the East partly by property of the heirs of the late Gaetano Polidano and partly by property of Mr. Clive Simpson, and on the South partly by a road and partly by property administered by Reverend Canon Paul Borg as Economo Beneficceji Vacanti; it is the property of Mr. Vincent Cachia as regards the Utile Dominium, and Reverend Canon Paul Borg as Economo Beneficceji Vacanti as regards the Directum Dominium.
8. A plot of land of the area of 5 Sieghan, including a farmhouse, bounded on the North by a road, on the West by property of Mr. Salvatore Agius, and on the East and South by Government property; it is the property of the heirs of the late Carmela Polidano.
9. A plot of land of the area of 3 Tumoli and 1 Siegh, including a farmhouse, bounded on the North by a road, on the East by property of the heirs of the late Carmela Polidano, and on the South by Government property; it is the property of Mr. Salvatore Agius.
10. A plot of land of the area of 3 Tumoli and 3 Sieghan, bounded on the North by a public road, on the East by property of Mr. Salvatore Agius, and on the West and South by Government property; it is the property of the Noble Chevalier Alexander Apap Bologna.
11. A plot of land of the area of 3 Tumoli including a farmhouse, bounded on the North by a public road and on the East and South by Government property; it is the property of the Noble Chevalier Alexander Apap Bologna.
12. A plot of land of the area of 2 Tumoli, 2 Sieghan and 5 Kejliet, bounded on the North and South by a public road, and on the East by property administered by the Reverend Canon Paul

Borg as Economo Beneficceji Vacanti as regards the Directum  
Dominium, and of Mr. Vincent Cachia as regards the Utile  
Dominium; it is administered by Reverend Canon Paul Borg as  
Economo Beneficceji Vacanti.

The abovementioned land is shown on a plan marked  
L.D. 52/69, which may be seen on demand at the Land Office,  
29, South Street, Valletta.
